Narrative:  
 On 08/13/2020 at approximately 0105 hours all Tacoma Police commissioned personal received an email by Detective Heilman in regards to a homicide that occurred the day before under TPD case number

2022501406. The email showed there was probable cause to arrest A1/DYRELL R SWINSON for Murder 1st Degree and Unlawful Possession of a Firearm 1st Degree. A1/SWINSON was also reported to be driving a gray 2008 Mercedes S Class bearing Washington license plate BPT2183. A1/SWINSON was to be considered armed and dangerous.

At approximately 0118 hours PPO Gustason (U403) advised dispatch over the air he was behind the above listed vehicle with the murder suspect A1/SWINSON in the area of S 36th St and Asotin St. I responded to the area to assist PPO Gustason who then advised the vehicle had crashed in the area of S 36th St and M St. Officers advised the vehicle was unoccupied and believed the suspect was running to his residence down the street located at 3633 S M St. A1/SWINSON was described by officers and witnesses as a light skin black male wearing a white t shirt and had dreads. A witness flagged down officers and advised A1/SWINSON had ran to 3633 S M St with a gun on his hip.

Upon my arrival Officers began to set containment around the residence. I positioned my patrol vehicle at the intersection of S L St and 37th St. Officers then were advised 911 callers were reporting seeing a man with a gun (A1/SWINSON) hiding in the alley behind 3633 S M St. The man was then described as hiding under the bushes behind the residence. I along with PPO McNeely (U184), PPO Roberts (X190), PPO Allman (U074), PPO Hollingsworth (U144) and Sgt. Martin (S033) began to clear the alley behind 3633 S M St to locate A1/SWINSON. While in the alley we continued our search for A1/SWINSON and were able to see in the yard where A1/SWINSON was reported to be hiding. A1/SWINSON was not in site at this time. K94 Syler and K92 Miller and other officers (unknown who at this time) had cleared the back yard of 3633 S M St and did not locate A1/SWINSON. While I was still in the alley with the officers above, I heard PPS Reetz (U154) who was at the front of the residence on S M St yell several times "Let me see your hands!" I observed PPS Reetz had his department issued rifle at a "low ready" position and began to advance to the south towards the front of 3635 S M St and out of my view.

Moments later I heard approximately 3 gun shots from a small caliber pistol. I then immediately heard 4-5 shots from a larger caliber which I believed to be a rifle. All officers in the alley including myself made our way to the front of the residence where I heard yelling. When I arrived in front of 3635 S M St I observed a blue 2004 GMC Yukon (WA/AWA7591) parked in the driveway of 3635 S M St facing south east. I observed A1/SWINSON lying on his back next to the front driver side wheel of the Yukon and was bleeding and had been placed in handcuffs by officers. Officers then began to render aid to A1/SWINSON and removed the handcuffs as Tacoma Fire arrived on scene. I observed next to the front driver side wheel of the Yukon was a black Glock 17 9mm (#BDBH142). The muzzle of the Glock was facing east while the grip was facing west. I then observed next to the Glock were 3 spent 9mm shell casings. A1/SWINSON was then transported by Tacoma Fire to Saint Joseph's Hospital where he is currently being treated for gunshot wounds. I observed on the sidewalk in front of 3635 S St were 5 spent .556 casings.

Tacoma Police K9 dog Ronja was struck by gun fire approximately 2 times and was transported to 5608 S Durango (Blue Pearl Veterinary) by K92 Miller where Ronja was taken into surgery for serious injuries. PPS Reetz was transported to Tacoma Police HQ by PPO Hollingsworth. It was later determined A1/SWINSON had fired 3 rounds at officers and the K9 which struck the K9 approximately 2 times. PPS Reetz returned fire and struck A1/SWINSON. I maintained scene security and the crime scene log. Lakewood Police officers arrived on scene and began their investigation. I maintained my position at S 37th St and M until I was relieved. There were several officers involved in this case. Please read their supplemental reports for further information. This concludes my involvement in this case. Nothing further at this time.

Narrative:	<p>On 8/13/20 at approximately 0118hrs I (PPO MCNEELY) was operating as a fully marked one-officer car (U184), on routine patrol in the City of Tacoma.</p> <p>It should be noted that during this shift I had been in contact with TPD Detectives in regards to a homicide that occurred around 1700hrs on 8/12/20 - and assisted with the identification of the suspect. At approximately 0105hrs TPD Detectives sent out a department wide bulletin (#S20-090) in regards for Probable Cause for the arrest of DYRELL R SWINSON (9/11/92) for Murder 1st and UPOF 1st reference a Homicide earlier in the shift (TPD #2022501406). The bulletin provided several addresses for A/SWINSON (814 S 13th St and 3633 S M St) and an associated Mercedes sedan (WA/BPT2183) and also two recent pictures of A/SWINSON. I am also familiar with A/SWINSON from prior contacts, with the most recent being on a traffic stop in July of 2020 - and know him to be an affiliate of the Knoccout Crips with a moniker of "DS".</p> <p>At approximately 0118hrs PPO GUSTASON (U403) advised on the radio that he had located the listed Mercedes sedan, occupied by a "Murder 1 suspect", in the area of S 36th St/S Asotin St. He advised that the vehicle was taking off and that he was in pursuit. A short pursuit ensued and the vehicle wrecked out in the area of S 36th St/S M St - with A/SWINSON bailing from the vehicle on foot.</p> <p>I arrived in the area a short time later as both PPO GUSTASON and SS911 Dispatch were providing updates of neighbors advising that a subject matching A/SWINSON'S description was seen fleeing the wrecked vehicle on foot, armed with a pistol. I advised incoming units that an associated address for A/SWINSON was 3633 S M St, and that we needed to "lock down" the block. I parked my fully marked patrol SUV, with lights fully activated, on the south east corner of S 37th St/S M St. As I did this SS911 Dispatch advised that a neighbor calling in had observed A/SWINSON, armed with a pistol, attempting to hide in a large thicket of bushes closest to the alley side behind 3633 S M St. With this new information, PPO ROBERTS (X190) and myself (whom are both members of the TPD SWAT Team) pushed up from our location at S 37th St/S M ST, to the mouth of the alley to the east - which was the location reported.</p> <p>We began coordinating with SGT MARTIN (S033) and responding units and quickly established a contact team consisting of myself, PPO ROBERTS, SGT MARTIN, PPO HOLLINGSWORTH (U144), PPO SEYLER and K9 RONJA(K9-4), and PPO MILLER (without K9 partner - K9-2). Our contact team then began advancing N/B in the alley in an attempt to get eyes on/observe the area of which was being described as the area A/SWINSON was hiding in. As we closed in behind 3635/3633/3631 S M ST, I began issuing loud verbal commands, "Tacoma Police, if you're back here make yourself known!" and even more specifically, "This is the Tacoma Police Department, Dyrell Swinson you are under arrest! We have a Police K9, make yourself known or you will be bit!"</p>

We slowly moved forward in the alley, clearing as we went, but were unsuccessful in finding A/SWINSON'S hiding spot in either the alley, or in the backyards of the aforementioned addresses from our vantage point above them in the alley. I gave the same loud verbal commands for the next 10-15 minutes, calling out to A/SWINSON intermittently from directly behind the 3635/3633/3631 triplex address. My verbal commands were clear, loud, and extremely specific to A/SWINSON that he was under arrest. As PPO SEYLER and K9 RONJA worked the area, the residents inside one of the triplex residences let SGT SMITH (S200) inside, into their second story, and were attempting to show him where they saw A/SWINDELL hiding in the bushes. The position they were indicating, was directly behind a 6ft tall wooden fence in the backyard. PPO SEYLER and K9 RONJA, PPO MILLER, and another TPD Officer entered that back yard and began dismantling the fence in hopes to deploy K9 RONJA in pursuit of A/SWINSON - while PPO ROBERTS and I provided cover from atop a roof of an adjoining garage directly north of 3631 S M St.

After the fence was dismantled enough, and K9 RONJA deployed to that specific spot, it was determined that the K9 team would come back to PPO ROBERTS and my position in the alley area - and we would continue the track/clearing from that point. While they were getting ready to exit the yard next to 3631 S M St, I suddenly heard PPS REETZ (U154) yelling "Show me your hands!" from the front of the residence. PPS REETZ provided a very loud and very clear command of "Show me your hands!", and I looked over to his location and saw him advancing, in a northern to southern direction, in the driveway of the listed triplex with his rifle raised in the low ready position. At this point I jumped from the roof of the garage, into the backyard, and along with two other TPD Officers began kicking through two wooden gates to get to the front. As we were doing this I heard at least two smaller gunshots (from a pistol caliber), and very quickly after heard a volley of 4-6 shots from a higher caliber weapon (rifle) in rapid succession. As we turned the corner into the driveway of the Triplex, TPD Officers advised "Shots Fired" and I observed A/SWINSON being pulled out from underneath a blue GMC Yukon parked in front of 3635 S M St - bleeding from his left arm and torso. I observed a black Glock pistol, with an extended magazine, laying to the front of the driver's side front tire of the Yukon - exactly where I had just observed A/SWINSON get pulled from. I then also observed 3 spent 9mm shell casings, believed to be from that Glock, two of which lying directly next to the same tire (touching the tire) - and the third was on the backside of the same tire (touching it underneath the driver's door area).

Officers on scene conducted a quick check of TPD personnel, and it was quickly discovered that K9 RONJA had been struck multiple times by gunfire from A/SWINSON'S pistol. PPO SEYLER, PPO MILLER, and SGT MARTIN quickly applied a tourniquet to K9 Ronja, whom was bleeding bright red blood profusely from her leg and torso, and self-transported K9 RONJA to the emergency vet. I again then checked with TPD OFFICERS on scene and asked if everyone was ok. It was determined that PPS REETZ had been the TPD Officer to fire, so PPO HOLLINGSWORTH was assigned as his peer support.

While this was occurring, TPD Officers began rendering aid immediately to A/SWINSON, whom had been struck multiple times by rifle fire by PPS REETZ. I was standing directly at A/SWINSON'S head, providing light to PPO ALLMAN and PPS ROSE rendering aid. I observed a GSW to his left forearm and multiple GSW'S to the left side of his torso. For the most part A/SWINSON was alert, conscious, and combative/uncooperative with Officer's attempting to render him aid. As Officer's were rendering life-saving aid to A/SWINSON, he was shouting that he was going to sue us, and that he wanted his Grandma to "call the NAACP". Shortly after TFD and AMR medical personnel arrived on scene, and he was transported to St Joseph Medical Center by Ambulance.

I was then assigned as inner crime scene security, nearest to the Yukon and evidentiary items surrounding it, until relieved by Lakewood PD SGT HALL and the Lakewood PD/WSP OIS team shortly before 0700hrs.

I then cleared the scene. Nothing further.

Narrative:	<p>On 08/13/20, I was working my assigned shift as the 3 Sector Patrol Sergeant as well as the K9 Unit Sergeant. I was wearing department issued police uniform. I was aware of an attempt to locate bulletin that had been distributed at 0105 hours regarding a Murder suspect, Dyrrell Swinson.</p> <p>At 0118hours, I was at S 38th and Thompson Ave, when I heard Officer S Gustason Jr advised that he had located the murder suspect's vehicle moving at S 36th and Asotin St. A pursuit was initiated and the suspect vehicle was lost soon after that. Numerous Officers responded to the area to assist. I was also quickly in the area when Officers located the suspect vehicle abandoned at 3600 S M St and empty. I arrived there as well with Officers Allman, W Gustason, and S Gustason. A citizen who lived mid block on the east side of M St was approaching us on foot. He stated he saw a light skinned male with braids, white shirt and a handgun in his back area running south on M St and turning into the front yard of 3633 S M St.</p> <p>I began to coordinate positions of arriving units. Sgt KP Smith arrived with me as well. We approached the front area of 3633 S M St. I could see a north side wood gate open that lead to the backyard of the attached duplex of 3633 S M St. From my position I could also see that what appeared to be the elevated alley directly behind. As Officers were arriving, dispatch advised a citizen reported seeing a light skinned black male with white shirt and a handgun off the alley behind 3633 S M St. The caller further advised the suspect was in some bushes behind the address.</p> <p>At this time, air support from WSP had arrived over head to assist. It appeared our best approach would be to access the rear from the elevated alley behind. I had instructed a couple Officers to remain on M St out front in case the suspect emerged or double backed. Myself and others maneuvered to S 37th St and then to the alley access to the north of 37th St. Several Officers were positioned there along with K9 Handler Syler and Handler Miller. It appeared the alley was only a lengthy driveway that ended in thick brush to the north of 3633 S M St.</p> <p>I instructed Officers to position for a tactical search north in the alley until we reached the rear of 3633 S M St. Dispatch continued to advise the caller stated the suspect was behind the residence, possibly behind a fence off the alley. Handler Syler with her police dog, K9 Ronja, assisted in the tactical search.</p> <p>We began to move north in the alley, clearing areas as we went. We arrived in an elevated position behind 3633 S M St backyard. From the alley, there was thick, deep blackberry brush the filled the area from the alley down to the backyard fence of 3633 S M St. Air support continued to check the area and at one point advised of a 'heat signature' behind us off a backyard of 3600 S L St. We continued to focus on the rear of 3633 S M St and set up positions of cover in case the suspect was located. Handler Syler continued to work K9 Ronja around the sticker brush but she stated she was not getting any indications.</p> <p>Sgt Smith had contacted the caller who then pointed to a specific spot behind his fence that bordered the alley/brush. Air support advised they were not seeing anything but the brush could be too thick. They then advised the area off L St was an animal. I instructed Handler Syler and Miller to get additional Officers and return out to the front of 3633 S M St and then enter the backyard thru the opened gate and clear the</p>

yard area with K9 Ronja. Myself and several Officers, Allman, McNeely, and Roberts remained off the alley in the elevated area for cover.

Handler Syler then entered the backyard and worked K9 Ronja around. They remove fence boards where the citizen said the suspect was behind. There area was cleared. I instructed them to finish clearing the backyard area of 3633 S M St and work around to the front. Once clear that, my plan was then to begin a track for the suspect as it seemed he may have fled on foot after the citizen saw him in the backyard.

Handler Syler, Miller, and Officer S Gustason began to work around to the south side of 3633 S M St and out of my view. Officer Reetz was positioned on M St for cover at this time. I then heard Officer Reetz begin yelling multiple times in loud clear commands "Show me your hands! Show me your hands!" Several seconds later I heard 5-8 gunshots from the front. I then went with other thru a backyard to the front.

I then observed Officers over the suspect Swanson and administering first aid. Fire was requested first aid. Officer Miller then told me K9 Ronja had been shot. I saw that K9 Ronja appeared to have been shot on the side and leg area. I told Handler Syler and Miller to get to their cars and get to Blue Pearl emergency Vet hospital at S 56th and Durango immediately. K9 Ronja was mobile but visibly in distress.

I was then advised no Officers were injured and first aid was continued for Swanson. Sgt Smith took over seen control at that point and I had no interaction or involvement at the seen. I then responded to the vet hospital and remained there until K9 Ronja succumbed to her injuries.

Handler Syler also remained with K9 Ronja for the duration. She showed me what appeared to be small lacerations on her neck area that she believed were from bullet fragmentation during the shots fired. TFD and forensics responded for treatment and photographs at the vet hospital.

I later cleared the seen from the vet hospital with no further involvement.

While on scene, I noticed a black, Glock pistol under the tire of a vehicle which was sitting in the driveway, in front of the location. I saw 3 shell casings lying adjacent to the pistol. It should be noted, the pistol and casings were within a couple of feet from where A/SWINSON was contacted. I stood by with the scene until relieved. While on scene, a female, O/UPCHURCH came out of 3633 S. M St. She identified herself as A/SWINSON's grandmother. She said she he had come over at about 1700 hours the previous day and he was acting strangely. She described him as being very worked up and excited. She said he was saying things like, "they are after me" and "I'm going to jail for a long time". O/UPCHURCH said she believed he may have been under the influence of some kind of narcotic.

I later responded to Tacoma PD Operations in a Peer Support role until relieved there.

Narrative:	<p>On 08-12-2020 I was assigned to the Tacoma Police Departments Violence Reduction Team. I was operating an unmarked white TPD SUV which was equipped with an interior light package as well as audible sirens. I was wearing a full TPD uniform to include Police badges and patches.</p> <p>Over the radio, I heard a TPD unit call out for priority traffic in regards to locating a possible murder 1 suspect (SWINSON), who was driving grey 2008 Mercedes sedan in the area of S 36th and Asotin St. The vehicle fled from the officer and was located stopped and unoccupied in the area of S 37th and S Cushman Ave.</p> <p>I arrived in the area and was directed by on scene units to set up in the area of the alley south of and behind the residence located at 3623 S M St, as SWINSON was last seen by witnesses running to the rear of the house, armed with a handgun. We were further advised that SWINSON was possibly seen hiding under a bush at the rear of the residence, near the alley.</p> <p>Along with multiple other units, I began to push southbound through the alley while Washington State Patrol's fixed wing aircraft circled above us, providing aerial observations. We were directed into the back yard of a triplex residence located near 3631 S M St. SWINSON had been seen possibly hiding in some sticker bushes just east of the fence line. While standing on the roof of a shed in the yard to the north, I provided overhead coverage while officers, including K9 Ronja and PPO SYLER began to check the yard. It was determined that no one was in the immediate yard, which was the northern most yard of the triplex.</p> <p>As the officers who were checking the triplex yards to the south, I began to move off the roof and began to move west through a yard, back towards S M St. While still in the alley behind the mentioned addresses, I hear an officers loud and clear commands of "Police, show me your hands!" as I observed the officer advancing south west from S M St, into the front parking are of the triplex. I heard the distinct sound of multiple small caliber pistol rounds being fired off with an immediate volley of rifle rounds being fired off. I began advancing through a yard, breaking down two locked wooden fences, in order to come to the front of the triplex. As I was moving towards the front, I heard a male voice screaming in a high pitch over and over. I came to the front and observed SWINSON lying on the ground with multiple gunshot wounds to his body. I further observed K9 Ronja had been struck by gunfire and was bleeding near the front door of the southernmost triplex unit.</p> <p>I assisted in providing medical aid equipment to officers working on SWINSON, who was bleeding heavily, until Tacoma Fire arrived on scene and transported him away.</p> <p>I observed what appeared to be a Glock 17 semi automatic pistol, lying under the front drivers side tire of a dark colored SUV parked in front of the triplex. The pistol had an extended magazine inserted into it which was wrapped in silver duct tape.
