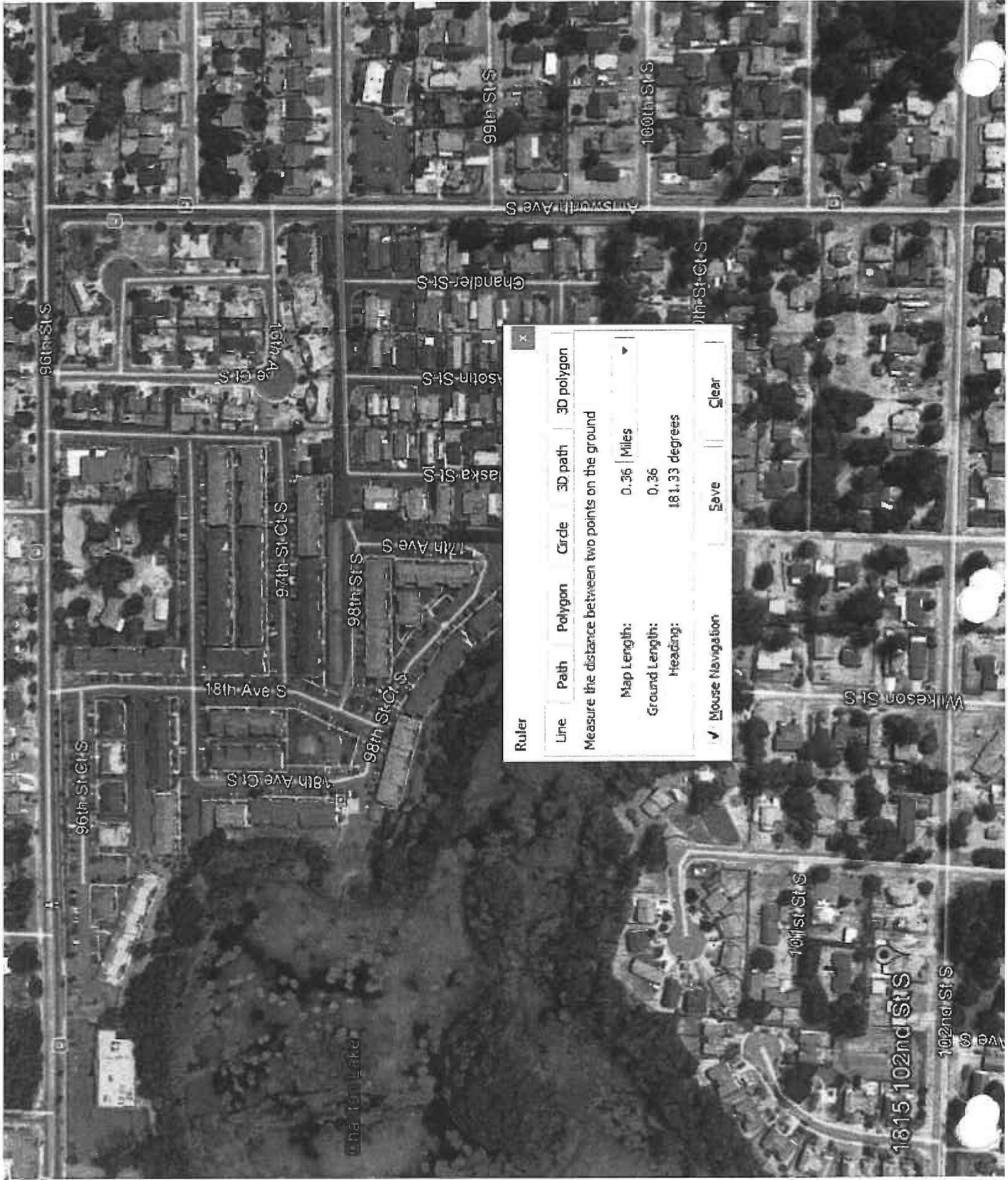

Verbatim Transcript from Recorded Interview
of JOE WHITE

March 25, 2021

Individuals present:
David Heitzman, Investigator with attorney general

TRANSCRIBED BY: Grace Hitchman, AAERT, CET-663

1 DAVID HEITZMAN: Okay. To start with do you
2 understand that this statement is being recorded?

3 JOE WHITE: Yes, I do.

4 DAVID HEITZMAN: And would you state your full name
5 and spell it, please.

6 JOE WHITE: Jody Lee White. That's J-O-D-Y, L-E-E,
7 W-H-I-T-E.

8 DAVID HEITZMAN: And would you state your address,
9 please.

10 JOE WHITE: 1438 96th Street South, Tacoma,
11 Washington 98444.

12 DAVID HEITZMAN: And what is the best telephone
13 number for you?

14 JOE WHITE: 206.755.2583.

15 DAVID HEITZMAN: And what is your date of birth?

16 JOE WHITE: [REDACTED]

17 DAVID HEITZMAN: Okay. All right. To start with,
18 how long have you lived in your present residence?

19 JOE WHITE: I believe about 20 years.

20 DAVID HEITZMAN: And could you describe the security
21 video system that you presently have at your house?

22 JOE WHITE: Yeah. We have a Vivint security system.
23 It's -- basically consists of four cameras, and one of those
24 is a doorbell camera that has sound. Other than that,
25 there's two door sensors, and that's about it. It's got

1 a -- video recording capabilities, but most of it's just
2 events.

3 DAVID HEITZMAN: Okay. So -- is there a name for
4 the particular system that you have? I'm assuming Vivint
5 has more than one.

6 JOE WHITE: No. As far as I know, it's just a
7 Vivint system. You just tell them how many cameras you want
8 for the setup and they come out and install it. So...

9 DAVID HEITZMAN: Okay. Now the date in question
10 that we're -- or the incident that we're looking into
11 happened on March 3rd of 2020. Was your system in place
12 that day?

13 JOE WHITE: It was in place. It was having some
14 recording issues because the memory was full on it. But it
15 was operating.

16 DAVID HEITZMAN: Okay. Could you describe the
17 issues that it was having?

18 JOE WHITE: Yeah. There's -- it has live video
19 recording to where it's continuous recording for 30 days
20 within a -- I don't know if it's within a month or within a
21 billing period. But it is only 30 days on one camera. And
22 at the time I didn't realize that. I had it set up so it
23 was fully recording all four cameras. So it ran out of live
24 recording playback within about seven or eight days. And so
25 at that point it still would capture anytime that it got

1 motion for about -- I think it's about a 30-second video.
2 But that was it. It wouldn't do a full live replay anymore.
3 So that was -- that was a part of what I was dealing with.
4 So...

5 DAVID HEITZMAN: Okay. And on March 3rd, where were
6 the cameras in place at your house?

7 JOE WHITE: We had the doorbell camera, and we had a
8 camera on the front of our garage, which views the driveway.
9 And then one of the side of our garage, which views the back
10 yard. And one on the back of the house, which views the
11 back door area. And those are the four cameras that we
12 have.

13 DAVID HEITZMAN: Okay. And so on March 3rd, what --
14 which cameras did you actually have video from on that
15 night?

16 JOE WHITE: Well, I know that we had video as far as
17 just 30-second clips from the doorbell camera.

18 DAVID HEITZMAN: Did you have recordings on -- from
19 any of the other cameras?

20 JOE WHITE: I do not recall.

21 DAVID HEITZMAN: Okay. Did you check?

22 JOE WHITE: I can no longer check.

23 DAVID HEITZMAN: I mean did you at the time?

24 JOE WHITE: I'm sure I did at the time.

25 DAVID HEITZMAN: Okay.

1 JOE WHITE: But -- because I -- when I went through
2 anything that I had that I thought had any -- anything, even
3 lights showing on it, I tried to send in. So...

4 DAVID HEITZMAN: Okay. Who installed the system?

5 JOE WHITE: Vivint has its own install crew that
6 came out and did it. We purchased it through Best Buy at
7 the time, and Vivint came out and installed.

8 DAVID HEITZMAN: Okay. Did -- have you made any
9 adjustments or changes since it was installed?

10 JOE WHITE: Just taking down cameras for remodel
11 work that has been done.

12 DAVID HEITZMAN: Okay. Was that before March 3rd of
13 2020 or after?

14 JOE WHITE: No. That's in the last four months.

15 DAVID HEITZMAN: Okay. Okay. When did you first
16 learn that an incident had happened with the police out in
17 front of your home?

18 JOE WHITE: I was -- I received a text message from
19 my son Kennet -- Kennet Ashford White -- when I was down in
20 Arizona the day of -- or actually the -- I don't know if it
21 was the day or the next -- I think it was probably the next
22 day. Yeah. It was the next day.

23 DAVID HEITZMAN: Okay. And following that, when did
24 you get home?

25 JOE WHITE: I believe it was about five days later.

1 DAVID HEITZMAN: Okay. Did you see any of the clips
2 before you got home?

3 JOE WHITE: No.

4 DAVID HEITZMAN: Okay. And then at some point you
5 -- I'm guessing you talked with an investigator or an
6 officer?

7 JOE WHITE: Yes. An officer -- I want to say his
8 first name was Don -- but had left a message asking that we
9 please send in any video surveillance that we might have.
10 And so when I got home, I contacted him and then emailed him
11 all of the -- all of the recordings that I was able to
12 access.

13 DAVID HEITZMAN: Okay. And do you know if you were
14 able to get all of them that were available on your system?
15 From that day?

16 JOE WHITE: Yes.

17 DAVID HEITZMAN: Okay. Okay. The doorbell camera
18 on the front -- on your front porch there, could you
19 describe how that's -- your understanding of how that's
20 designed to work?

21 JOE WHITE: It's triggered by motion, so sometimes
22 it's triggered by light. And it -- whenever it senses
23 movement, then it records or -- yeah, I guess it records for
24 about 30 seconds or so. And picks up not only visual but
25 auditory recordings. That's it.

1 DAVID HEITZMAN: Okay. And is -- so the system is
2 designed to only record 30-second clips at a time? Is that
3 correct?

4 JOE WHITE: That's -- well, depending on the memory
5 available on the DVR, I guess, or whatever is holding the --
6 holding the memories. If there's still time available like
7 the beginning of a billing cycle or the beginning of a
8 recording cycle, you can have continuous playback. But
9 during that time, all that I had available was clips. So it
10 shows a clip that you can easily access going back through
11 memory, and usually from that clip you can go into a full
12 live recording for up to 30 days. But at the time of the
13 incident, all that it was doing was allowing me to do the --
14 I think it was about 30-second clips every time it sensed
15 motion.

16 DAVID HEITZMAN: Okay. And what have you found to
17 be, I guess, the range for that front door camera?

18 JOE WHITE: That generally it's people right up on
19 the sidewalk approach to my front steps.

20 DAVID HEITZMAN: Uh-huh.

21 JOE WHITE: Anybody who comes up there as a person
22 triggers it. It will also occasionally be triggered by
23 somebody walking on the city sidewalk close to my house. Or
24 it will get triggered by a vehicle that has a reflective
25 surface like a school bus or a white-sided truck if lights

1 hit it just right. Or flashing lights will generally also
2 trigger it. Especially after night -- after nightfall.

3 DAVID HEITZMAN: Okay. So when was the first time
4 that you viewed the recordings from the night of March 3rd
5 then?

6 JOE WHITE: I can't remember for sure, but I want to
7 say it was probably six or seven days afterwards.

8 DAVID HEITZMAN: Okay.

9 JOE WHITE: So 9th, 10th, something like that.

10 DAVID HEITZMAN: Okay. And what was the process for
11 you putting the videos -- files in a format that you were
12 able to -- were you able to email it to the investigator?

13 JOE WHITE: Yes. If I remember correctly, I went
14 down and got on my computer and went to the Vivint site,
15 logged in, and was able to view the clips. And there's an
16 option to save the clips on there, and so I believe I saved
17 the clips and then sent them in. I think there was -- it
18 took multiple emails to send them in. I can't remember if
19 it was two or three.

20 DAVID HEITZMAN: Okay.

21 JOE WHITE: About six or seven emails -- about six
22 or seven video clips per email.

23 DAVID HEITZMAN: Okay. And I think you said earlier
24 it was your goal to find as much as you were able to
25 regarding the incident?

1 JOE WHITE: Yes.

2 DAVID HEITZMAN: Okay.

3 JOE WHITE: Yeah. I believe I sent everything in
4 from before the incident -- starting right before the
5 incident, the first time that the camera had been triggered
6 prior to the incident, I guess, and then until late that
7 night I think until everything had settled down and it
8 wasn't -- there were no more flashing lights in front of the
9 house. I think I sent one after that.

10 DAVID HEITZMAN: Okay.

11 JOE WHITE: So...

12 DAVID HEITZMAN: Okay. Do you know the name of the
13 gentleman that passed away last night -- or, I'm sorry, that
14 night? With this -- during his contact with the police?

15 JOE WHITE: Yes. Manny Ellis.

16 DAVID HEITZMAN: Okay. Did you know Manny Ellis or
17 know that name before that incident?

18 JOE WHITE: I did not.

19 DAVID HEITZMAN: Okay. Okay. I think that's all
20 the questions I have. Anything else that I maybe forgot to
21 ask that you think might be important? In re --

22 JOE WHITE: That's all that I can think of.

23 DAVID HEITZMAN: Okay.

24 JOE WHITE: So...

25 DAVID HEITZMAN: Okay. Joe, do you certify or

1 declare that the facts stated on this recording are true and
2 correct to the best of your knowledge and that your
3 statement has been made freely, voluntarily, and without
4 threats or promises of any kind?

5 JOE WHITE: Yes, I do.

6 DAVID HEITZMAN: Okay. I'm going to stop this now.
7 The time is 1719 hours. And this concludes the recording.

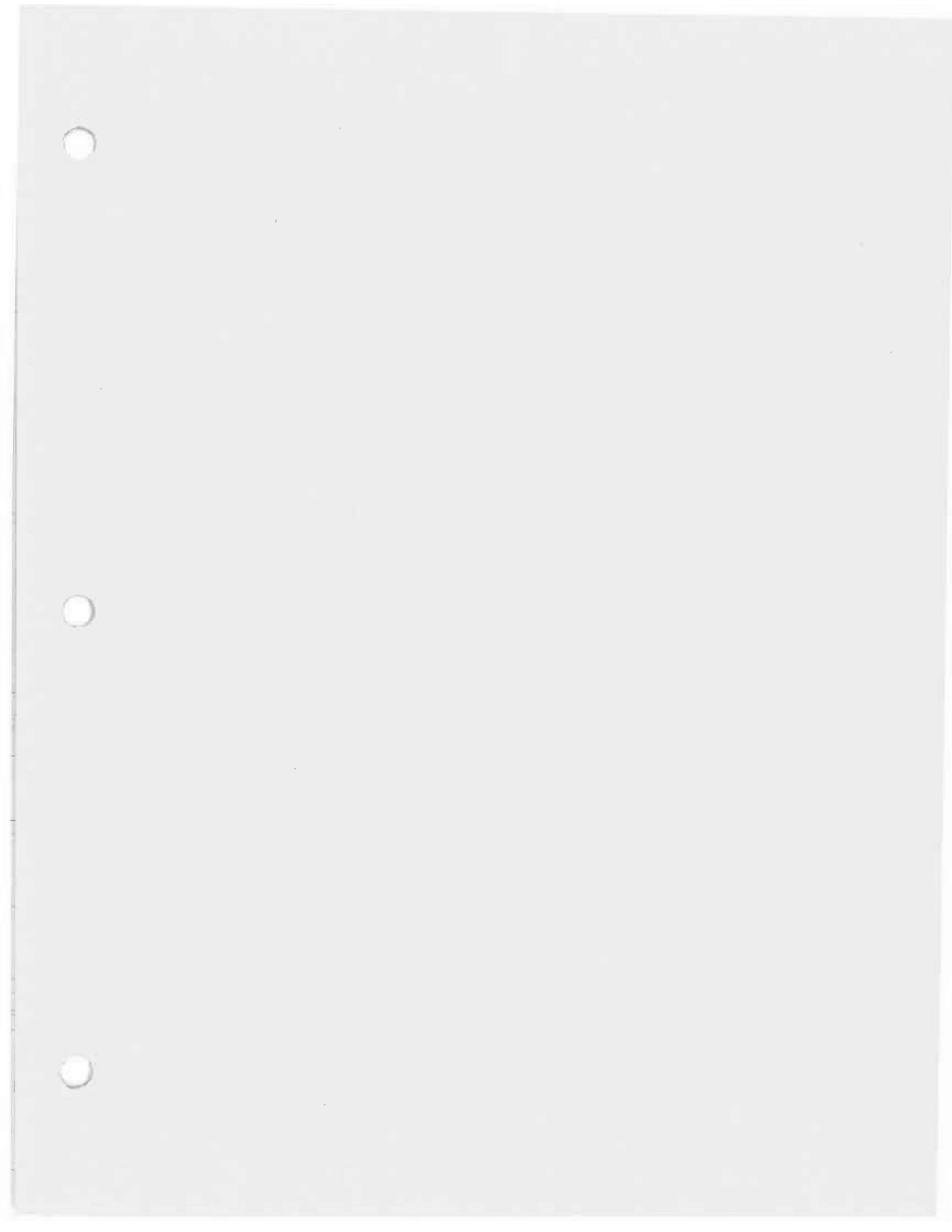
