#### 4. DESIGN REVIEW

# a. 620 N. Ainsworth (North Slope Historic District) Garage & deck remodel

Mr. McKnight read the staff report as provided in the packet.

Vice-Chair Mortensen expressed appreciation to the owner for adding on to the garage instead of replacing. Commissioner Johnson had clarifying questions about the height and roof of the new garage. Vice-Chair Mortensen wanted clarification on whether vinyl windows were acceptable per the Commission's guidelines.

Vice-Chair Mortensen made a motion: "I move that the Landmarks Preservation Commission approve the application for 620 N. Ainsworth Ave., with the update as presented in the discussion to include wood frame windows and metal doors, with no texturing as the applicant submitted."

Commissioner Johnson seconded the motion. It passed unanimously.

### b. Rialto Security Enhancements

Mr. McKnight read the staff report as provided in the packet.

Erin Anderson, KPG, provided a project summary and updates since the last briefing with the Commission. She explained the three matching gates had been added. Drawings and further information on how the gates would be installed were presented. Permit applications were under review.

Vice-Chair Mortensen asked for details about where the connecting bolts would go, which would be the plaster area between the tile and the trim at the bottom of the dome. Commissioner Johnson inquired about the material underneath the plaster, implying potential structural impact by the drill holes for the bolts. He also commented on the level of resistance to pressure of the gates, and the possibility of them falling over if being pushed. Commissioner Hilsendeger had a similar question about the rigidity of the gates. Chair Bartoy suggested having a restoration plan documented as part of the process, since the solutions were intended to be temporary.

Vice-Chair Mortensen made a motion: "I move that the Landmarks Preservation Commission approve the application for 310 S. 9th St., Rialto Theatre, as submitted, with the recommendation that a restoration plan be developed for future."

Commissioner Hilsendeger seconded the motion. It passed unanimously.

# a. Additional Information for 1010 N. L St.—garage remodel

Mr. McKnight informed the Commission that the siding of the garage was vinyl but it was existing, and there was no plan to change or replace.
