CALL TO ORDER

- (b) The Group reviewed and responded to the Transportation Commission's letter to the Infrastructure, Planning, and Sustainability Committee regarding TODAG resolution and future, dated November 10, 2021.
- (c) Lihuang Wung outlined the draft resolution scheduled for the City Council's adoption on December 14, 2021, regarding the extension of TODAG operations.
- (d) The Group discussed providing public comment at the City Council meeting of December 14 and having a joint meeting with the Transportation Commission to discuss recommendations.
- (e) Mr. Wung reviewed TODAG's work plan for 2022 and beyond, and suggested it be approved, assuming the City Council will adopt the resolution on December 14. The Group decided to delay the approval of the work plan until after the City Council's direction.
