Legislative Updates

Mike Shaw, Pierce County Government Relations – Election Summary based on preliminary results

Initiatives:

I-1631 Carbon Tax – possibly part of the legislative transportation package; I-1634 Grocery; I-1639 Firearms; I-940 Law enforcement – legislative deal to amend initiative in two years

Legislature:

Seven new Democrat members in House of Representatives (57 Dem – 50 Rep) Three new Senate members (28 Dems – 21 Rep) Senate Democrats re-org next Monday – determine leadership

Pierce County Legislative Agenda:

- Criminal defense costs
- WSH Legislative Task force brief (Council Member Ladenburg)
 Working with stakeholders to ensure safety of patients released into our community, staff and residents.
- State pay fair share of election costs jurisdictions pay their own cost. State only funds in odd years (not even years)
- Other request items

Randy Lewis – City of Tacoma general overview of Legislative Agenda (Dec. 4th release)

- Shared revenues from state to cities/counties for affordable housing (amount unknown);
 - Mandate what is to be done or suggest how money spent (?)
- Legislative Transportation Committee Members tour of projects; Puyallup River Bridge replace two of the nine sections; however, no money (grants) for remaining sections needing replacement (large traffic loads over 30k vehicles per day)
- Highway 167 and culverts
- (Murray Morgan bridge paid with Puyallup Land Claim settlement left-over funds and WA State)

Josh Garcia - Tacoma Public Schools request of State (three focus areas):

- Operational funding levies
- Fully fund special education (14% population in Tacoma Schools)
- 60% construction bond to simple majority let local community decide
- Other:

Discussion regarding special education funding following the student (between districts) Increased needs for special needs, mental health and homelessness

Andrew Austin - Metro Parks Tacoma preliminary overview:

- Homelessness: funding and enforcement
- Commissioner compensation legislative proposal
- Zoo/conservation advocacy
- Whole child initiative
- Foss Waterway parks support legislative ask
- South Tacoma (10-minute walk level of service standards) capital request
- Operational dollars (partnership) work with school district; reduce costs to citizens
- Use Asset Mapping: what are the spaces, when available? School/parks
- Parks and Schools work jointly on capital projects (design?)
- Titlow lagoon project for salmon
- Norm Gollub update on Foss Waterway parks
 Regional rowing and children's park (46% from government 54% from private funding)

Anders Ibsen - City of Tacoma

- Preserve home rule authority
- Increase library funding: remote/mobile library units, add a librarian Co-locate and partner with Metro Parks
