AGENDA ITEMS

Foss Waterway Development Authority

Executive Director of Foss Waterway, Norm Gollub, explained the origination of the FWDA and its mission, cultural amenities, museums, marinas, public boat access, future plans such as the 15th Street Pier and Floats Replacement Project, cruise ship docking area, Melanie Dressel Park, Waterway Park, infrastructure plans such as the 2019 wood and walkway removal, 2020 seawall replacement, proposed development such as The Village at Foss Harbor (A Maritime Urban Community), and the Tacoma Fast Ferry Feasibility Study which was completed in early February 2019.

2019 Action – The Governor's budget requests an \$350,000 award to the Puget Sound Regional Council to update their 2008 Puget Sound Regional Passenger-only Ferry Study and cover the entire Puget Sound. It was clarified that passenger only ferries are not part of the state ferry system; they are owned and managed by regional transit authority such as Kitsap Transit with its Fast Ferry service.

There are 99 live-aboard residents, and 900 permanent residents in the area.

Sub-Area Plan Presentation

Steve Victor explained Sub-Area planning versus regular city area planning and how it benefits and impacts the jurisdictions. Issues looked at include employment, traffic, environment, residential development, and fossil fuels. Puget Sound Regional Council has given this Sub-Area Planning Task Force a two-year window to complete their work.

Review Topics and Focus for 2019

Chair Petrich relayed that Anita Gallagher has requested a Tacoma Public Utilities presentation at June or July for Advanced Metering. Mr. Campbell asked whether that topic was relevant to all members of JMAC, including the school district and tribe.
