BRIEFING ITEMS

Welcome New Members

At approximately 6:16p.m., Chair Strautman gave an overview of the Citizen Police Advisory Committee's history and mission.

City Manager's Office

At approximately 6:18p.m., L. Ware gave an update on staffing changes to affect CPAC due to City-wide furloughs. Committee advised that L. Ware will leave for furlough on June 19, 2020 and Bucoda Warren will return as temporary furlough until further notice.

CTRT Update

At approximately 6:20 p.m., L. Ware reported that L. Morris of Tacoma Fire Department (TFD) was invited to attend meeting but did not respond to request (noting that non-response potentially due to last minute request made and staffing constraints on TFD. L. Ware advised committee that staff would follow-up on this request by extending an invitation to the committee's July meeting.

The committee made an administrative change to create a CTRT sub-committee to assist with reviewing the potential of revisiting and extending a second request for proposal (RFP). The sub-committee will consist of three members and CM's Edwards and Altamimy agreed to lead these efforts.

At approximately 6:37p.m., Chair Strautman made mention that Mayor Woodards reached out to him to express support in an expansion of CPAC powers. This notation was a Segway into the next agenda item.

Action plan for proactive engagement and communication with the TPD, the City, and Sheriff's Department with CPAC related to officer involved homicides and incidences of hate crimes At approximately 6:40p.m., committee members expressed interest in increased communication with TPD staff. Committee members request the following action items:

- A complication of City and TPD press releases Executive Liaison T. Jumper advised she would work with her staff (Media and Communications Department (MCO) to grant this request
- Incident notification of officer involved shootings and when a person dies in TPD custody Chief Ake stated this request could be granted through compilation of nightly reports sent to the City Manager

Action plan for CPAC functionality during emergencies, natural disasters, pandemics, etc. and Review of Community correspondence, and discussion of response

At 6:53 p.m., committee members engaged in discussion around expansion of powers to activate resident groups and volunteers to respond to community members during emergencies (to include but not limited to police state & protest, natural disasters, pandemics, family members of officer involved shootings). Committee members decided they will draft a response to community members that reach out to include but not limited to information on what CPAC does and what they are currently working on.

CPAC Retreat – schedule new date

Committee's annual planning retreat was canceled in April 2020 due to Governor ordered emergency response to COVID-19. Committee agreed to reschedule for early August 2020. Staff Liaison L. Ware to send a poll to committee members to see if the committee is available August 1, 2020 or August 8, 2020, and reschedule venue for the retreat.

Vice Chair Hagberg reported that he will work to review documents sent from TPD prior to today's meeting and work within the sub-committee on recent policy matters related TPD and CPAC.
