- 6:07 Lydia presented a PPT on CIRA's Community Safety sub-committee
- Presentation contents:
 - Issues:
 - Language barriers
 - Use of children as interpreters
 - Cultural/experiential differences wrt police (decentralized)
 - Trauma
 - Threats preventing the reporting of crimes
 - Reporting property crimes
 - NWIPC detainees don't know or can't report crimes
 - Hate speech
 - CIRA CSC Wins:
 - TPD one touch access to professional translators in 150+ languages 24/7
 - Other city services following suit
 - TPD policy not to use children as interpreters unless an emergency situation
 - TPD legal determined TPD has jurisdiction over crimes committed in NWIPC
 - Ongoing Work
 - Getting Blue Cards (incident cards) translated into multiple languages and officers trained to explain information using professional interpreters
 - Media and Communication working on translation and QR codes
 - Distributing reporting crimes cards in multiple languages
 - English, Spanish, Vietnamese, Cambodian, Russian, Korean; asked for Arabic and Amharic
 - Outreach and reporting crimes cards into NWIPC
 - Trauma Informed Policing training proposal with immigrants and refugees
 - Talking with TPD & State Criminal Justice Training Commission
 - Anti-hate campaign: Be Kind Tacoma. No Room for Hate
 - Waiting to hear from Media and Communication
- Angela let the committee know any cellphone with power can dial 911, Lydia responded that
 while this is true detainees at the NW Ice Processing Center don't have access to cellphones.
- Lydia suggested it would be useful for TPD to present regularly at the NWIPC on the rights the detainees still have while imprisoned there.

- Staff will check on who is the TPD liaison to the NWIPC since Curtis left the force.
- Trauma Informed Policing is something CIRA is working on and floated that it could be a good topic for the CPAC policy committee to research.

 - The point was made that while rudeness may not cause direct harm, it could create a situation that otherwise would never have occurred because the person responds differently than if an officer had entered the situation trying to help the person or at least treated them respectfully.
 - BWC have played a role in many of these complaints, often confirming the officer's side of the story.
