5. Discussion/Updates

a. Tacoma Arts Month Recap

(17:07)

Staff gave an update about Tacoma Arts Month and shared data about the impact of the Tacoma Studio Tour and Arts at the Armory, including artist participation by Council District. Commissioners discussed.

b. Diversity, Equity & Inclusion Subcommittee

(23:01)

Commissioner Stump gave an summary of the Diversity, Equity, & Inclusion (DEI) subcommittee's November 17 meeting including: reviewing and updating the language for the Municipal Art Collection Gift Donation Form, discussion about potential topics for future subcommittee meetings, staff attending a panel discussion titled "Arts Recovery Through Anti-Racist Action" which will be shared with the subcommittee once available, onboarding new Commissioners, and looking at ways local organizations could pair and open their spaces to creatives.

6. Action Items

a. Municipal Art Collection Equity Statement

(26:54)

Staff shared the following draft of an Equity Statement for inclusion in documents related to Municipal Art Collection. The DEI subcommittee has reviewed and revised the statement.

"In alignment with Tacoma City Council Resolution 40622, the Tacoma Arts Commission is committed to sustained and transformational anti-racist work and seeks to reverse historical inequities and imbalances in resource allocation when considering artworks to be included in the Municipal Art Collection and/or for work to be sited on City property or City Rights of Way. *Resource allocation means any money, staff time, and/or space that is required to manage and steward the artwork if accepted." Commissioners discussed.

b. 2023 Community Arts Projects Funding Recommendations

(30:21)

Staff shared an overview of the 2023 Community Arts Projects funding application review process. There were seven panelists including Commissioners Stump and Williams, Derek Nunn, Erin Tail, Curtis Ashby, Sarah Chavez, and Amy Van Mechelen. Thirty-five applications were received with a total request of \$195,000. The panel recommended distribution of \$138,000. Staff shared the panel's recommendation on
