Staff is requesting the TCRA Board approve a single-family rehabilitation budget for a project located at 3710 S. Alaska, Tacoma WA 98418. Board approval will allow staff to move forward with the rehabilitation of the home and correct the numerous health and safety concerns that need to be addressed. The expansive amount of rehabilitation work necessary has significantly increased the project costs, as well as industry wide material cost increases over the past several months. The SFR Program is requesting approval for the total project value of \$314,677.00 (Contractor bid, including tax \$285,677.00 + \$29,000.00 (10%) project contingency).

The expansive amount of rehabilitation work necessary has significantly increased the project costs, as well as industry wide material cost increases over the past several months. The SFR Program is requesting approval for the total project value of \$219,091.50 (Contractor bid, including tax \$199,091.50 + \$20,000.00 (10%) project contingency).
