**MOTION:** Meredith Neal moved to approve the consent agenda with an amendment to the August 12, 2021 TCRA Meeting Minutes, which corrects the chair of meeting from Dan Montopoli to Meredith Neal. Steve Snider seconded the motion, which passed unanimously.

#### **HOUSING**

4. Pacific Property Transfer Agreement

Staff requested final action on the transfer of City of Tacoma-owned, surplus property to the TCRA.

**MOTION:** Steve Snider moved to authorize acceptance of the 35<sup>th</sup> and Pacific Property with the terms outlined in the transition agreement and authorize the TCRA Administrator to execute the transition agreement via resolution. Meredith Neal seconded the motion, which passed unanimously.

5. 2021-22 Affordable Housing Notice of Funding Availability (NOFA) Recommendations

Staff recommended that the Board commit \$2,981,088 from the Affordable Housing Fund and \$770,584 in HOME funds for award to four projects through the Affordable Housing NOFA. Staff further recommended that the TCRA form a waitlist to reserve a portion of the City of Tacoma HOME Consortium PY21 Home Investment Partnerships American Rescue Plan (HOME-ARP) Program funds in the amount of \$3,393,278 for two projects.

**MOTION:** Terri Scott moved to commit the following funding amounts for Affordable Housing:

Low Income Housing Institute – Lincoln District Phase 1, Requested: \$3,750,000, Committed: \$1,473,761 Shiloh Baptist/New Life Housing – Shiloh Redevelopment, Requested: \$1,956,279, Committed: \$1,956,279 Rescue Mission – Tyler Lifecycle Replacement, Requested: \$121,632, Committed: \$121,632 Washington State Housing Finance Commission – Tacoma Down Payment Assistance Program, Requested: \$100,000, Committed: \$200,000 Habitat for Humanity – Proctor Place, Requested \$800,000, Committed: \$0 MacDonald Ladd Development LLC/Vaughn Bay – The Lookout, Requested: \$2,000,000, Committed: \$0

In addition, to reserve American Rescue Act HOME-ARP funds for the following projects and amounts. Funding commitment is contingent on staff review of project eligibility with HOME-ARP program guidelines, availability of the federal funds, and final board approval:

Low Income Housing Institute – Lincoln District Phase 1, Requested: \$3,750,000, Reserved: \$2,276,239 Tacoma Housing Authority – 1500 Hillside, Requested: \$1,117,039, Reserved: \$1,117,039

Karsen Keever seconded the motion, which passed unanimously.
