2. CDBG Community & Economic Development NOFA: Staff Recommendations - Felicia Medlen

The Board was provided with a background of the funding priorities for Community Development Block Grants (CDBG) made available through the 2021 Community & Economic Development Notice of Funding Availablility (NOFA), the available funding program amounts, the process used to evaluate the applications, and a summary of each eligible project. The Board had an opportunity to comment on the development of funding priorities and staff recommendations.

Staff recommended to commit the following funding amounts for Housing and Economic Development projects:

2a. Rebuilding Together South Sound – Tacoma Home Repair, Requested: \$660,000 Funding Recommendation: \$660,000

2b. Rebuilding Together South Sound – Rebuilding Day and Safe at Home Projects, Requested: \$81,500 Funding Recommendation: \$81,500

2c. Tacoma/Pierce County Habitat for Humanity – Critical Home Repairs for Seniors, Veterans, and Persons with Disabilities, Requested: \$200,000 Funding Recommendation: \$157,615

2d. Tacoma Pierce County Chamber of Commerce – Spaceworks Tacoma - Creative Enterprise, Requested: \$195,000 Funding Recommendation: \$150,000

2e. Urban Business Support – Urban Business Support, Requested: \$100,000 Funding Recommendation: \$0

2f. William Factory Small Business Incubator – Inclusive Entrepreneurial Ecostystem, Requested: \$97,180 Funding Recommendation: \$0

2g. Mercy Corps Northwest – Creating Inclusive Growth, Requested: \$150,000 Funding Recommendation: \$150,000

2h. Business Impact Northwest – Technical Assistance for Microenterprises in Pierce County, Requested: \$175,000 Funding Recommendation: \$0

MOTION: Meredith Neal moved to adopt staff recommendations as presented for projects to receive funding through the 2021 CDBG Community & Economic Development NOFA, and to be included in the 2021-2022 Annual Action Plan. Terri Scott seconded the motion, which passed unanimously.
