3. <u>City of Tacoma Resurgence Loan Update – Will Suarez</u>

Staff presented an overview of applicants for the City of Tacoma Resurgence Loan by industry, gender, ethnicity, race, and councilmanic district. Of 177 applicants, 51 were recommended to receive loans ranging from \$10,000 to \$25,000 at a 2.44% fixed interest rate for a term of five years with a one-year deferment period.

**MOTION:** Jason Kors moved to approve the allocation of \$1,170,000 EDA CARES Act Revolving Loan Funds to 51 small business recipients as presented by staff. Meredith Neal seconded the motion, which passed unanimously.
