CONSENT AGENDA

MOTION: Meredith Neal moved to adopt items presented in th Consent Agenda. Joseph van Dyk seconded the motion, which passed unanimously.

ADMINISTRATION

3. Loan Write-Off Request

Staff provided the Board with a summary of loans in the TCRA portfolio that have no recourse action to be taken due to an executed settlement agreement.

MOTION: Joseph van Dyk moved to authorize the write-off of two loans at an amount of \$48,966.27 and remove them from accounting and loan servicing systems. Karsen Keever seconded the motion, which passed unanimously.

4. TCRA Board Member Orientation

Staff provided the Board an orientation on the TCRA's history, purpose, and operational structure. Presentation was informational, no action was taken.

HOUSING

5. Notice of Funding Availability for Affordable Housing Projects

Staff provided the Board with an overview and timeline for the TCRA 2021 Affordable Housing Notice of Funding Availability. Verbal correction was made to the amount of funds available to adjust for a previous TCRA commitment. A total of \$770,584 of HOME Program funds are available through the NOFA instead of \$1,168,999, which was listed in the NOFA memo included in the agenda packet. Presentation was informational, no action was taken.

ECONOMIC DEVELOPMENT

6. City of Tacoma Deferral of Revolving Loan Fund Payments for Stabilization Loan Borrowers

Staff recommended that Tacoma S&C LLC and Tacoma Improvement Club LLC receive a six-month deferral of Stabilization Loan payments.

MOTION: Meredith Neal moved to authorize Tacoma S&C LLC and Tacoma Improvement Club to defer loan payments, including principal and interest, for a period of one year from May 1, 2021 through May 1, 2022, and that the additional year be added to the loan maturity date. Joseph van Dyk seconded the motion, which passed unanimously.

EXECUTIVE SESSION

Executive Session was called at 8:17 AM to discuss legal risk of property ownership with counsel and adjourned at 8:47 AM.
