## 2. Lincoln District Senior Housing Project – Heidi Burbidge & Tammi Garofalo

Staff requested approval of loan terms and authorization for the Tacoma Community Redevelopment Authority (TCRA) Administrator to execute the loan documents and related security documents with Lincoln Senior Housing LLLP for the Lincoln District Senior Housing project.

3. 2024 Annual Action Planning & CED CDBG NOFA – Jason Mejia & Taylor Palmer Jenson

4. CDBG-CV Emergency Mortgage Assistance/Foreclosure Prevention – Heidi Burbidge
