III. Land Acknowledgment – Interim Vice Chair Saucedo

The Commission acknowledges that the meeting is being conducted on Indigenous lands of the Puyallup People, who cared for their ancestral lands before the Medicine Creek Treaty of 1854 removed native peoples to clear way for colonial settlement. It is important to this Commission as settlers here, aspiring to care for immigrants and refugees in this place and to call it home, that we acknowledge and send gratitude to the Puyallup Tribe of Indians who continue to be leaders for justice in our community today.

VI. City Staff Updates – Liaison Raeshawna

- a. Landlord-Tenant Information Landlord-Tenant Coordinator ChiQuata Elder Main Points:
 - i. As the landlord-tenant coordinator, Elder helps to enforce the WA State Residential Landlord-Tenant Act and Tacoma Rental Housing Code TMC 1.95.
 - ii. On May 10^{th,} 2021, WA became a "just cause" eviction state. There are 17 business reasons as to why a landlord can terminate the tenancy.
 - iii. The COT rental housing codes are enforceable through more than a civil action. COT Rental housing code can apply penalties to landlords. This enforcement has led to many landlords coming into full compliance with the code.
 - iv. Future actions include adding language to the code in regards to:
 - 1. Shared housing update (HUD is allowing those with section 8 to use room rental/shared housing due to the increased need for housing options).
 - 2. Tenant late fees (some landlords wait until the end of a tenancy to notify renters of accrued late fees which could become a barrier).
 - 3. Landlord having to have a business license in order to issue evictions. The business license is used to contact landlords of changes to the codes, policies and ensure compliance.
 - 4. Notice of sale to low-income tenants. (If a person is low-income it will likely take them longer to relocate).
 - v. The city is looking at ways to support proper housing conditions and intervene when necessary, particularly for immigrants and refugees. (For example: if a building utility is off, but there is no formal complaint). This falls under the affordable housing action strategies of the City.

Question: Is the COT looking to partner with the landlord to ask them to offer more affordable housing options? Hieu

Response: COT is doing that in a number of ways through the tax credit, through updates of policies, and through the affordable housing actions to get them to do more affordable housing.

Question: Any upcoming communication to the immigrant community? Hieu **Response**: COT does targeted communication, and can provide the information to the staff liaison to send to you if there are community forums and feedback opportunities. ChiQuata

Question: In setting structures or updates in the code – How long does it take? What happens in the meantime? What have you been seeing since the moratorium? How are you finding out if landlords are out of compliance with the "just cause"? How do people know about their rights? Is there a communication strategy? Alma

Response: The just cause eviction came into being in May prior to the end of the moratorium in September. We use our phone calls to know if landlords are in

There have been several pieces of training through the state, THA, and our organization. The only recourse is the civil action renters can take in accordance with state law. The first Rental Housing Code passed in seven months. It is a high priority. If we could get it passed by the end of the year would be ideal. ChiQuata **Response**: Communication strategy support is coming from the new position we are recruiting – If CIRA can help us identify the trusted messengers in the community that would be helpful. We could partner with CIRA on some of the changes that are being proposed, a consideration for the CIRA workplan of 2022. Lisa **Question**: Is there a handout available describing the changes, and in multiple languages? Could not find anything on the website. Links would be great. Lydia **Response**: We do not have a handout yet, we are updating the website, we can work on translating materials. We are looking at creating a one-pager though. **Question**: How can we contact you for more questions? Saiyare **Response**: <u>Rental Housing Code</u>, <u>TacomaRHC@cityoftacoma.org</u>. celder@cityoftacoma.org.

Question: What are some protections for those who fear reporting. Raeshawna **Response**: Can go online Or call 253-591-500, Or 311. We do not disclose any identifying information, and there is a retaliation cause in the Rental Housing Code. The only time they are disclosed is when they request an inspection.

 - i. Will be contacting the commissioners for questions regarding needs and transition.
- c. Website Updates Liaison Raeshawna Ware
 - i. Samantha is the webpage manager.
 - ii. Did send governance committee requests to Sam which requests an updated photo, workplan, and pertinent CIRA information be uploaded to the webpage.
 - iii. About 90% of agendas and minutes are uploaded to the website.
 - iv. The next step is to have telelanguage work on translating the material, which is going to be a long process.
- d. Other Relevant Updates
 - i. Thanks for the willingness to participate in the Police chief recruitment Alma, great question. Raeshawna. Comment: The person selected was the one who responded most interesting to the question about causing harm to the community, although the response was satisfactory. Would like a follow conversation about that. Alma
