III. Land Acknowledgment – Commissioner Natalie Ghayoumi

The Commission acknowledges that the meeting is being conducted on Indigenous lands of the Puyallup People, who cared for their ancestral lands before the Medicine Creek Treaty of 1854 removed native peoples to clear way for colonial settlement. It is important to this Commission as settlers here, aspiring to care for immigrants and refugees in this place and to call it home, that we acknowledge and send gratitude to the Puyallup Tribe of Indians who continue to be leaders for justice in our community today.

Chair would like to continue this conversation in the governance committee, and asked for additional time that would work for those who would like to participate in the conversation and to send follow up email following the meeting. - e. Committee Discussion: Guest of Alma Villegas, Maria Gamez the Language Access Coordinator in the City of Tacoma, would like to brief commissioners interested in Language Justice Committee on upcoming activities CIRA could advise on. They are working on drafting a working document for language access to become Language Justice. To make sure that in the COT other languages are offered and have proper interpretation.
- f. Committee Updates and Overview of work. Please include the next meeting date and time.
 - Community Safety Committee- Is Concerned about High levels of Covid, and sanitation in the detention Center, there were 58 cases in June. We are concerned that entire pods are being quarantined and hence detainees are at risk of being reinfected. Are the detainees receiving adequate medical care? CSC calls for an investigation by the TPCHD and/or the WA state Department of health. This was moved by Commissioner -Vo and Seconded by Commissioner -Valdez Castro and passed CSC unanimously. CSC would like for CIRA to take this concern and promote/present to Council committee. Motion made by CSC, Seconded by Commissioner- Ghayoumi, called to vote; the ayes have it and has been approved.
 - Governance (of CIRA) Committee- The Governance Committee has more to discuss and still need more to join the committee.
 - Language Justice Committee- The Language Justice Committee has just restarted, there are only a couple people on the committee and are looking for more participants.

Why do we recognize the land?

To recognize the land is an expression of gratitude and appreciation to those whose territory you reside on, and a way of honoring the Indigenous people who have been living and working on the land from time immemorial. It is important to understand the long-standing history that has brought you to reside on the land, and to seek to understand your place within that history. Land acknowledgements do not exist in a past tense, or historical context: colonialism is a current ongoing process, and we need to build our mindfulness of our present participation. It is also worth noting that acknowledging the land is Indigenous protocol.

(Comments/Discussion Surrounding Welcoming Week and other events)

- *Gathering information and promoting within networks on Social media. CIRA should be supporting others and elevating efforts and refugee/immigrants. Avoid Tokenism
- *Don't have enough manpower, time or funds to put on a separate event. COT shouldn't make us do everything.
- *Lets make sure that this isn't just a token event. Needs to be a real partnership amongst all.
- *If COT took more ownership and properly funded event, it would be easier to partner and execute.
- *Ethiopians celebrate their New Year on September 11th, and it was frowned upon because to others who aren't apart of their community it looked like they were celebrating the 9/11 attacks. They do not want to celebrate their new year in fear of being branded as terrorists. Awareness and partnership is needed in our communities.
- *Getting all leaders in COT together and asking what the community needs.
- *Newsletter highlighting organizations who already do the work. More community engagement.
- *COT looks to the boards, commissions, committees for feedback on how things are going. When you have something important you want to celebrate. We need to know one another more. Take time to figure out what is important and pick maybe 3 things to focus on first. Start with your networks.
- *CIRA asked for staff support and a budget and was told COT could provide up to \$5k. Which is not enough to put on an event.
- *Who do you trust to represent your communities?
- *What is Welcoming America? Answered: From Lydia Zepeda My understanding is that Welcoming Week is not a CIRA event, but a commitment that the City made and then asked CIRA to do for them. What we have said is that we do not have the capacity to organize an event, especially without a budget.
