II. Statement of Purpose – Vice Alma Villegas

We convene this meeting to advance the City of Tacoma's mission to "reducing barriers to access and participation in Tacoma's economic, cultural, and civic life for immigrants and refugees." This Commission aspires to help "make the City more vibrant, inclusive, and welcoming for all."

# VI. Commission Affairs

## a. Welcoming Week Proclamation Discussion (with guest) and Vote

Guest speaker was not present. Could we reschedule representative from Ethiopian Community (Sophia) to come and speak at next CIRA meeting?

## Proclamation Discussion:

Commissioner Villegas made motion to pass proclamation.

Commissioner Valdez Castro: motion to amend. If possible, would like more time to discuss the word "genocide" in reference to turmoil in Ethiopia, as it is very sensitive/political depending on the ethnic group people belong to. Suggests using "horrific turmoil" in place of genocide to describe ongoing political issues.

Commissioner Villegas: Seconded using horrific turmoil

Commissioner Zepeda: Secondary amendment to say, "ongoing suffering of the people in Ethiopia." Commissioner Kowalski: noted correcting "Afghani Refugees" to "Afghan Refuges"

Chair Donaldson: Call to vote on Proclamation as amended.

The ayes have it; the motion passes, and commissioners will add "on going suffering" to the Proclamation.

Welcoming Week Proclamation to be presented to Tacoma City Council September 13<sup>th</sup>, 2022.

- b. Welcoming Week Event Discussion: What are the Tacoma Refugee Choir, APCC, KWA, LUSS, Tacoma Community House, and others doing around this time we can elevate as a recommendation for the City of Tacoma to support?

## **Community Safety Committee:**

- Community Safety had a successful meeting, where Council Members Ushka and Walker were present.
- Tacoma-Pierce County Health Department (TPCHD) claims not to have jurisdiction over Northwest ICE Processing Center (NW ICP). Concern for health & safety of people detained continues. Washington State Heath Department & Attorney General have all written letters to GEO Group without response.
- Tacoma Police Department (TPD) does have jurisdiction over NW ICP facility and have responded to crimes reported in the center. The people detained cannot call 911, but only the non-emergency line. Police response times to crimes can take weeks.
- TPD Community Liaison suggested that the legal department of TPCHD speak to the legal department of the TPD about jurisdiction of NW ICP because it's owned by GEO group. Both legal departments (TPD & TPCHD) seem to have different understanding of jurisdiction and should speak to each other.
- People detained at NW ICPare charged \$1 a minute for phone calls. Federal mandates require free 1-800 numbers to report sexual assault and other crimes, but calls go unanswered. Council Member Rumbaugh was present & asked how she might elevate the issue of reports to 1-800 numbers going unanswered.
- Committee intends to connect with US Representative Kilmer to address on-going concerns at detention center. Rep. Kilmer has the authority to request a visit of the center.
- Next committee meeting: Monday September 12<sup>th</sup> at 3:30 p.m. (2<sup>nd</sup> Monday of the Month).
  Council Members expressed that Community Safety committee is the best platform for community members to voice concern about NW ICP centers.

## Governance (of CIRA) Committee:

- Governance is newest committee; working on getting new members acclimated.
- Primary focus of last committee meeting was to work on the Welcoming Week Proclamation.
- One goal of the Governance committee is to vet agenda ideas and guest speakers and bring to the committee of the whole.

## Language Justice Committee (LJC):

- Working on drafting language for Language Justice Resolution. Council intends to pass the resolution sometime in the Spring of 2023. Expectation is that LJC will give input into the resolution and draft plan, and present proposals for Language Justice plan.
