We convene this meeting to advance the City of Tacoma's mission to "reducing barriers to access and participation in Tacoma's economic, cultural, and civic life for immigrants and refugees." This Commission aspires to help "make the City more vibrant, inclusive, and welcoming for all."

III. Land Acknowledgment – Commissioner Maurice Lekea

The Commission acknowledges that the meeting is being conducted on Indigenous lands of the Puyallup People, who cared for their ancestral lands before the Medicine Creek Treaty of 1854 removed native peoples to clear way for colonial settlement. It is important to this Commission as settlers here, aspiring to care for immigrants and refugees in this place and to call it home, that we acknowledge and send gratitude to the Puyallup Tribe of Indians who continue to be leaders for justice in our community today.

VII. Commission Affairs

a. November 2023 and December 2023 Meeting dates

b. Bylaws amendment update

Staff spoke with Legal. Legal wrote a position on the current and proposed version of CIRA bylaws. Staff to send Legal's written response to commissioners. Staff to continue dialogue with Legal in preparation for the November Meeting.

- c. Proclamation for Elimination of Violence Against Women and Human Rights Day CIRA will bring forward this proclamation to Tacoma City Council. CIRA would like to work with the Human Rights Commission (HRC) on the proclamation. Staff liaisons will work to support the proclamation finalization. The date to turn in the proclamation to the Chief Policy Analyst is November 14th. The date for the proclamation reading is set for November 21st at 5:00 pm.
- d. Committee survey updates

Chair Ghayoumi reviewed the results from the Committee Survey via PowerPoint and posed suggestions on how to proceed. Commissioner Sands was the only commissioner that was not named on any committee at the time of the survey and decided to join the Community Safety Committee. Commissioner Donaldson is interested in joining the Recruitment and Welcoming Week Committee. Chair Ghayoumi would like to consider joining the Recruitment and Welcoming Week Committee together. Commissioner Le is interested in Welcoming Week and Governance but cannot attend the current governance meeting time/date. A comment to consider "if you don't have anything to discuss at a committee meeting, cancel it."

g. Community member spotlight by a commissioner

Chair Ghayoumi discussed a suggestion for each commissioner to find a community member to be spotlighted (not organizations) at CIRA meetings that is inspirational, or their work is important to CIRA. CIRA responded favorably to this suggestion. No decisions were made on who to invite in November. However, some consideration like anonymity was discussed.

h. Committee Updates and Overview of work.

• Community Safety Committee

Met with Captain Darlington and Lieutenant Katz on 09/28. Received additional TPD 1000 resource cards in Vietnamese. Trying to get Blue Cards, Incident Cards to be translated into other languages and having police go over the card with victims. There is a need for detainee reporting crime cards and outreach at the detention for clarifying their rights. Need to address hate speech and slurs – we may need a city campaign on city civility. Would like to work with TPD on around what issues immigrants face and the difference good policing can make.

Question: Is there a penalty for "hate speech?" How can we protect those being verbally attacked?

Answer: - Varied Reponses - threat speech is likely punishable.

Question: Can CIRA go in to the NWIPC to tell them about resources and reporting crime. Because folks may have fled due to uniformed personnel. it may be better for a group outside of TPD to go.

Answer: TPD does this in other communities and could do this with NWIPC. It would be likely be TPD, not CIRA.

Question: Are the resource cards available in Farsi and Arabic cards?

Answer: Not currently.
