## MEETING NOTES (DRAFT)

**DATE:** Thursday, July 8, 2021

### 1. Initial input on Rental Code update

- a. ChiQuata Elder provided an overview of the project intent and timeline.
- b. The HET discussed outreach approach ideas including reaching out to Pierce County Housing Authority, THA, Homeless Services Coalition, Associated Ministries and Hilltop Action Coalition.
- c. Engagement ideas: Use data and stories to communicate. In-person engagement is very important particularly for BIPOC, immigrant and refugee communities. Door to door canvassing.
- d. The HET requested the webpage and project overview to disseminate within their networks.
- e. The HET discussed topics, including: Allowing more time to rescind the 20 day notice; just cause evictions; and prioritizing people of color who are more affected by rental crises.

### 2. Finalize HET's 2<sup>nd</sup> Home in Tacoma Project letter

- a. The HET reviewed and approved the final comment letter to be forwarded to the City Council.

### 3. Initial input on Anti-displacement Strategy

- a. Staff provided an overview of existing and proposed anti-displacement policies and actions and requested input regarding whether other actions should be included in an Antidisplacement strategy.
- b. The HET discussed potential additional actions and questions including the following:
  - Property taxes are skyrocketing. Research existing breaks for elderly, people with disabilities.
  - Shared housing – promoting shared housing programs to help seniors and cost burdened people, to open up homes to shared housing renters.
  - Do more to publicize and inform people of resources available.
  - Consider neighborhood resources like grocery stores, employment, hospitals, transportation.
  - Factors to consider in prioritization: Probability of completion, timeframe, feasibility, what can be done most quickly, critical part is time.
  - A survey or group activity like Mentimeter would be a useful way to refine HET guidance
