Commissioner Givens thanked staff for the information on additional revenue.

2. Development and Permitting Activity Update

Shirley Schultz, Principal Planner in Current Planning, presented the permitting and development activity update, including publicly available reports on www.tacomapermits.org, an overview of permits issued in the last five years, permitting activity of 2019 versus 2020, new commercial and residential permitting activity of 2021 through quarter three, example projects, and other PDS highlights.

Chair Petersen and Commissioner Strobel provided comments on receiving updates when there are code changes and how those changes affect permitting activity.

Commissioner Strobel requested information on Multifamily Tax Exemption (MFTE) performance.

Commissioner Santhuff provided comments regarding affordability and missing middle housing and asked about requirements on construction notice signs.
