I. Call to Order

Co-Chair Stevens called the meeting to order at 5:33 PM.

II. Roll Call

Co-Chair Morris was absent. CM Wrenn and CM Nyland are excused absences.

III. Review of Minutes (July 19, 2023)

CM Gardner moved to approve the minutes. CM Korbuszewski seconded the motion. The minutes were approved with a revision under Commission comments.

IV. Public Comment on Agenda Topics

No members of the public provided comment.

V. Business Items (5:45)

Joint Transit-Oriented Development Task Force (Action) – Carrie Wilhelme, Public Works
Co-Chair Stevens and Carrie Wilhelme provided an overview of the Joint Planning Commission and
Transportation Commission Transit Oriented Development Task Force (Joint TOD Task Force), including the
prior work of the Transit Oriented Development Advisory Group (TODAG), Council resolution, and goals for the
Joint TOD Task Force.

Co-Chair Stevens requested volunteers and for the Commission appoint two representatives and one alternate to serve on the Joint TOD Task Force. Commissioner Casas and Commissioner Serad volunteered. Co-Chair Stevens volunteered to be an alternate. Noting that Commission Wrenn had expressed interest to join the Joint TOD Task Force but was unable to attend today, Commissioner Casas offered to cede his position on the Joint TOD Task Force should Commissioner Wrenn still be interested. Co-Chair Stevens agreed he would be willing to do that as well.



CM Gardner moved to appoint CM Serad and CM Casas to the Joint TOD Task Force with Co-Chair Stevens as the alternate. CM Serad seconded the motion. The minutes were approved with an amendment.

Next, Co-Chair Stevens and Carrie requested comments on the draft Joint TOD Task Force Charter. There were some clarifying questions but no suggested changes.

CM Goble moved to approve the draft Joint TOD Task Force charter. CM Casas seconded the motion. The draft Joint TOD Task Force charter was approved as written.

- Commission Presentation to IPS (Discussion) Carrie Wilhelme, Public Works and Bruce Morris, Co-Chair Co-Chair Stevens and Carrie explained that the Co-Chairs have been invited to present to the IPS Council Sub-Committee regarding the Transportation Commission on October 11, 2023. Co-Chairs Stevens and Morris wanted to hear from the Commission on what accomplishments should be highlighted along with future hopes and goals of the Commission. Commissioners mentioned their work collaborating and supporting other Boards and Commissions and being involved in long range planning projects. They also expressed a need to increase staffing focused on active transportation and transit, funding and resources to decrease single occupancy vehicle trips and increase multimodal trips (e.g. missing link sidewalk funds), and making sure the urban canopy is included in Complete Neighborhoods.
- c) Bus Rapid Transit and Next Steps (Discussion) Carrie Wilhelme, Public Works and Matt Stevens, Co-Chair Tina Lee, Pierce Transit Planning Manager, joined the Transportation Commission in a discussion regarding BRT and enhanced bus service along Pacific Avenue. Tina provided an overview of what the enhanced bus service will include and stated the estimated timeframe for the new service is April/May 2024. She explained that BRT is still the long-term vision for this corridor. The Commission discussed funding options (sales tax increase), service expansion, and next steps for the Commission in regards to BRT. Commissioner Grellier offered to bring the enhanced service outreach plan to the Commission for comment. Tina offered to return in November or December as part of the Title 6 requirements for the new service.

VI. Other Business/Updates (6:45)

a) Bicycle Pedestrian Technical Advisory Group (Joe Korbuszewski)

BPTAG Chair Jenn Halverson-Kuehn joined CM Korbuszewski in providing an overview of the July BPTAG

meeting. Metro Parks had presented about changes regarding 5-mile loop in Point Defiance Park, and BPTAG

had concerns. The Commission shared in the concerns, offered ideas and suggestions of support, including

drafting a letter to the Metro Parks Board that endorsed the letter sent by BPTAG. The Commission voted to

write a letter, and CM Korbuszewski volunteered to write the letter.

 Program grant. If awarded, grant funds will be used to do planning, design, and engagement to study

 overpasses and underpasses for I-5 in Tacoma to improve safety and accessibility for all travel users.
