This information IS NOT considered an addendum. Respondents should consider this information when submitting their proposals.

Question 1: Do you anticipate the need for temporary fencing or portable restrooms?

- Answer 1: The Contractor is provided a staging area for the project at both locations as shown on the plans. It is up to the Contractor to decide if temporary fencing and portable restrooms are needed to facility the work. The staging area is an unsecured area in the downtown corridor.
- Question 2: Is there a specific time for the pre-proposal meeting or do we just visit the site on our own?
- Answer 2: See Addendum 1.

Question 3: Will ADA compliant curb ramps be required at Site B?

- Answer 3: The City is working on updated drawings to add curb ramp at the corner. This drawing change will include additional concrete slab and utility adjustments. The drawing change will be issued by addendum.
