1. BACKGROUND

The City of Tacoma (City) and Tacoma Public Utilities (TPU) is soliciting bids to establish one or more contracts with qualified vendors to fulfill the City's needs for official legal publishing on an as-needed basis for up to six years. The City anticipates awarding a single contract. However, the City reserves the right to split the award, reduce the award, or make no award, if it is in the City's best interest. Any Contract issued as a result of this solicitation is not exclusive. The City reserves the right to purchase from other contractors if the successful Respondent cannot provide the required products or services in a timely manner.

Submittals and/or the selected Consultant(s) may be used for projects of similar type and scope at the sole discretion of the City for up to one year

2. MINIMUM REQUIREMENTS

- **2.1** Publish a daily newspaper that has been established, publishing, and circulating in Tacoma, Washington, for at least six months prior to the submittal deadline.
- **2.2** Publish a daily newspaper that meets all qualifications of a legal newspaper as set forth in Chapter 65.16 RCW, as those qualifications exist now or are hereafter amended.
- 2.3 Compliance with all state and local laws pertinent to a legal newspaper
- **2.4** Obtain an Order of Approval of the Superior Court in accordance with Chapter 65.16 RCW prior to contract award.

3. SCOPE OF SERVICES AND DELIVERABLES

It is the City's intent to select a consultant based on qualifications and abilities of the firm and key project individuals.

3.1 Introduction

- 3.1.1 Publish various City of Tacoma notices including but not limited to public notices, legal notices, and official notices.
- 3.1.2 Submittals will be accepted for a newspaper that is published daily (at least five times per week, Monday-Friday).

3.2 Technical Requirements

- 3.2.1 Minimum point size is 6-point type.
- 3.2.2 Minimum leading is 6 points.
- 3.2.3 Printing will be set in solid or with typeset quality or equivalent; or photographically reduced for publication; or optically scanned.

Request for Proposal

- 3.2.4 Receive publication requests by email, fax, or hardcopy. Honor publishing requests regardless of the format in which they are received, as long as they are received by the minimum lead time for publication.
- 3.2.5 Print in said newspaper upon request, after requested copy has been provided, all summaries of ordinances, resolutions, and legal notices, public notices, and official notices for and on behalf of the City, on all requested publication dates, without mistake or variance from the copy furnished. Failure to perform will be considered noncompliance with this Contract.
- 3.2.6 All legal publishing shall be placed together under the block title "City of Tacoma Legal Notices" in the legal notice section of said newspaper.
- 3.2.7 Ordinances and Resolutions may be photographically reduced for publication by Contractor as long as the requirements are met. The City will not pay more for photographically reduced copy than if the copy had been typeset. Maps, photos, graphs, mathematical formulas, graphic designs, etc., which are photographically reduced for printing shall be measured for payment purposed based on the actual number of column inches of the copy printed.
- 3.2.8 Furnish and deliver 65 copies of each day's issue of said newspaper, at no additional charge, to the City Clerk's office, Tacoma Municipal Building North, 733 Market Street, Room 11, in downtown Tacoma, by the day following publication.
- 3.2.9 Furnish the required number "Affidavit of Publication" certifying the dates in which the advertisement was published, after the last publication date of the advertisement, to the City department or agency that submitted the publication request, at no additional charge.
- 3.2.10 Pickup advertising copy on an as needed basis, anticipated to be a rare occurrence, at the City Clerk's office, Tacoma Municipal Building North, 733 Market Street, Room 11, or at a specified Tacoma Public Utilities office, 3628 S 35th Street. Pickups shall be scheduled to ensure next day publication of specified items.
- 3.2.11 Provide a subscription to any person or organization that request it in reasonable time frame, but in no event, not more than three weeks from the date of request. If the City receives five written complaints from potential subscribers who have been unable to obtain a subscription to said newspaper, which complaints are verified, Contractor shall be deemed to be in material default of this Contract.
- 3.2.12 Furnish all affidavits with a copy of each particular published. Affidavits must be signed and notarized. If Contractor fails to provide accurate affidavits and accurate publication dates, Contractor shall be deemed to be in material default of this Contract.
- 3.2.13 Print accurate dates of when items were actually published at the end of the published document.

- 3.2.14 Requests for publication received by noon the day before the requested day of publication shall be ensured of next day publication. Variations from this time frame may be approved by the City Clerk's office or the affected City department submitting the publication request.
- 3.2.15 Contractor shall maintain an office located within the corporate boundaries of city of Tacoma for purposes of pickup and delivery of documents, affidavits, etc.
- 3.2.16 Have and maintain an operating facsimile machine available on a 24-hour basis to accommodate the City and/or other agencies' delivery of publication requests and documents. If the fax machine becomes inoperable, it shall be the Contractor's responsibility to notify the City Clerk's office at 253-591-5505 and the Purchasing Division 253-502-8468 of the interruption of service.
- 3.2.17 The city will not pay for any advertisement that is improperly run. Contractor will republish improperly run advertisements at its own expense. Any additional costs incurred by the City from an improperly run advertisement will be passed on to Contractor.

3.3 Billing/Invoicing

- 3.3.1 Selected vendors will be required to complete enablement and transact in Ariba, the City's invoice submittal portal.
- 3.3.2 Independently invoice separate City departments or agencies as requested by the City.
- 3.3.3 Provide monthly individualized, itemized statements of each account listing the invoice number, item published, and total amount of each invoice to the separate departments of the City, e.g., General Government, Tacoma Public Utilities, and other using agencies, making the publication request.

4. CONTRACT TERM

The contract will be for a three-year period with the option to renew the contract two additional two-year terms. The City reserves the right to cancel the contract for any reason, by written notice, as stipulated in the contract.

The SAC may determine additional scoring criteria for the interviews following evaluation of written submittals.

The City reserves all rights to begin contract negotiations without conducting interviews.

Respondents must be available to interview within three business days notice.

If interviews are conducted, the SAC will schedule the interviews with the contact person provided in the SOQs. Additional interview information will be provided at the time of invitation. At this time, it is anticipated that the main objective of the interview will be for the SAC to meet the project manager and key personnel that will have direct involvement with the project and hear about their relevant experience and expertise. The City does not intend to meet with firm officials unless they are to be directly involved with the project.

Following interviews, submittals will be rescored using the same criteria as stated in the evaluation criteria section

12. RESPONSIVENESS

Respondents agree their submittal is valid until a contract(s) has been executed.

All submittals will be reviewed by the City to determine compliance with the requirements and instructions specified in this RFP. The Respondent is specifically notified that failure to comply with any part of this RFP may result in rejection of the submittal as non-responsive. The City reserves the right, in its sole discretion, to waive irregularities deemed immaterial.

The final selection, if any, will be that submittal which, after review of submissions and potential interviews, in the sole judgement of the City, best meets the requirements set forth in this RFP.

13. ACCEPTANCE / REJECTION OF SUBMITTALS

- **13.1** Respondents are advised that the City reserves the right to cancel award of this Contract at any time before execution of the Contract by both parties if cancellation is deemed to be in the City's best interest. In submitting a Submittal, Respondents agree that the City is not liable for any costs or damages for the cancellation of an award.
- **13.2** The City reserves the right and holds at its discretion the following rights and options:
 - To waive any or all informalities
 - To award one or more contracts
 - To not award a contract
 - To issue subsequent solicitation

14. CONTRACT OBLIGATION

The selected Respondent(s) will be expected to execute a contract with the City. As part of the negotiation process, Respondents may propose amendments to the contract, but the City, at its sole option, will decide whether to open discussion on each proposed amendment and determine the final contract to be used. At a minimum, any contract will incorporate the terms and conditions contained herein along with the entirety of the respondent's submittal.

18. PARTNERSHIPS

The City reserves the right to select more than one Prime Respondent.

19. COMMITMENT OF FIRM KEY PERSONNEL

Should key personnel become unavailable for any reason, the selected Respondent shall provide suitable replacement personnel, subject to the approval of the City. Failure by CITY to identify a deficiency in the insurance documentation provided by CONTRACTOR or failure of CITY to demand verification of coverage or compliance by CONTRACTOR with these insurance requirements shall not be construed as a waiver of CONTRACTOR's obligation to maintain such insurance.

29. Nondiscrimination

The CONTRACTOR agrees to take all steps necessary to comply with all federal, state, and City laws and policies regarding non-discrimination and equal employment opportunities. Thus, the CITY may be required, upon request, to disclose this Contract and documents related to it unless an exemption under the Public Records Act or other laws applies. In the event CITY receives a request for such disclosure, determines in its legal judgment that no applicable exemption to disclosure applies, and CONTRACTOR has complied with the requirements herein to mark all content considered to be confidential or proprietary, CITY agrees to provide CONTRACTOR ten (10) days written notice of impending release. Should legal action thereafter be initiated by CONTRACTOR to enjoin or otherwise prevent such release, all expense of any such litigation shall be borne by CONTRACTOR, including any damages, attorneys fees or costs awarded by reason of having opposed disclosure. CITY shall not be liable for any release where notice was provided and CONTRACTOR took no action to oppose the release of information. Notice of any proposed release of

APPENDIX A

CONTRACTOR will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice to be provided advising the said labor union or workers' representatives of the contractor's commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- E. CONTRACTOR will comply with all provisions of Executive Order 11246 of September 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.
- G. In the event of CONTRACTOR's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this Contract may be canceled, terminated, or suspended in whole or in part and the CONTRACTOR may be declared ineligible for further federally funded contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- H. CONTRACTOR will include the portion of the sentence immediately preceding paragraph (A) and the provisions of paragraphs (A) through (G) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. CONTRACTOR will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance:

City of Tacoma Insurance Requirements

This Insurance Requirements shall serve as an attachment and/or exhibit form to the Contract. The Agency entering a Contract with City of Tacoma, whether designated as a Supplier, Contractor, Vendor, Proposer, Bidder, Respondent, Seller, Merchant, Service Provider, or otherwise referred to as "Contractor".

1. GENERAL REQUIREMENTS

The following General Requirements apply to Contractor and to Subcontractor(s) performing services and/or activities pursuant to the terms of this Contract. Contractor acknowledges and agrees to the following insurance requirements:

- 1.1. Contractor shall not begin work under the Contract until the required insurance has been obtained and approved by the City of Tacoma.
- 1.2. Contractor shall keep in force during the entire term of the Contract, at no expense to the City of Tacoma, the insurance coverage and limits of liability listed below and for Thirty (30) calendar days after completion of all work required by the Contract, unless otherwise provided herein.
- 1.3. Liability insurance policies, except for Professional Liability and Workers' Compensation, shall:
 - 1.3.1. Name the City of Tacoma and its officers, elected officials, employees, and agents as **additional insured**
 - 1.3.2. Be considered primary and non-contributory for all claims with any insurance or self-insurance or limits of liability maintained by the City of Tacoma
 - 1.3.3. Contain a "Waiver of Subrogation" clause in favor of City of Tacoma
 - 1.3.4. Include a "Separation of Insureds" clause that applies coverage separately to each insured and additional insured
 - 1.3.5. Name the "City of Tacoma" on certificates of insurance and endorsements and not a specific person or department
 - 1.3.6. Be for both ongoing and completed operations using Insurance Services Office (ISO) form CG 20 10 04 13 and CG 20 37 04 13 or the equivalent
 - 1.3.7. Be satisfied by a single primary limit or by a combination of a primary policy and a separate excess umbrella
- 1.4. A notation of coverage enhancements on the Certificate of Insurance shall not satisfy these requirements below. Verification of coverage shall include:
 - 1.4.1. An ACORD certificate or equivalent
 - 1.4.2. Copies of requested endorsements
- 1.5. Contractor shall provide to City of Tacoma Procurement & Payable Division, prior to the execution of the Contract, Certificate(s) of Insurance and endorsements from the insurer certifying the coverage of all insurance required herein. Contract or Permit number and the City Department must be shown on the Certificate of Insurance.
- 1.6. A renewal Certificate of Insurance shall be provided electronically prior to coverage

expiration via email sent annually to coi@cityoftacoma.org.

- 1.7. Contractor shall send a notice of cancellation or non-renewal of this required insurance within Thirty (30) calendar days to coi@cityoftacoma.org.
- 1.8. "Claims-Made" coverages, except for pollution coverage, shall be maintained for a minimum of three years following the expiration or earlier termination of the Contract. Pollution coverage shall be maintained for six years following the expiration of the Contract. The retroactive date shall be prior to or coincident with the effective date of the Contract.
- 1.9. Each insurance policy must be written by companies licensed or authorized (or issued as surplus line by Washington surplus line broker) in the State of Washington pursuant to RCW 48 with an (A-) VII or higher in the A.M. Best key rating guide.
- 1.10. Contractor shall not allow any insurance to be cancelled, voided, suspended, or reduced in coverage/limits, or lapse during any term of this Contract. Otherwise, it shall constitute a material breach of the Contract.
- 1.11. Contractor shall be responsible for the payment of all premiums, deductibles and self-insured retentions, and shall indemnify and hold the City of Tacoma harmless to the extent such a deductible or self-insured retained limit may apply to the City of Tacoma as an additional insured. Any deductible or self-insured retained limits in excess of Twenty Five Thousand Dollars (\$25,000) must be disclosed and approved by City of Tacoma Risk Manager and shown on the Certificate of Insurance.
- 1.12. City of Tacoma reserves the right to review insurance requirements during any term of the Contract and to require that Contractor make reasonable adjustments when the scope of services changes.
- 1.13. All costs for insurance are included in the initial Contract and no additional payment will be made by City of Tacoma to Contractor.
- 1.14. Insurance coverages specified in this Contract are not intended and will not be interpreted to limit the responsibility or liability of Contractor or Subcontractor(s).
- 1.15. Failure by City of Tacoma to identify a deficiency in the insurance documentation or to verify coverage or compliance by Contractor with these insurance requirements shall not be construed as a waiver of Contractor's obligation to maintain such insurance.
- 1.16. If Contractor is a government agency or self-insured for any of the above insurance requirements, Contractor shall be liable for any self-insured retention or deductible portion of any claim for which insurance is required. A certification of self-insurance shall be attached and incorporated by reference and shall constitute compliance with this Section.

2. SUBCONTRACTORS

It is Contractor's responsibility to ensure that each subcontractor obtain and maintain adequate liability insurance coverage that applies to the service provided. Contractor shall provide evidence of such insurance upon City of Tacoma's request. Failure of any subcontractor to comply with insurance requirements does not limit Contractor's liability or responsibility.

3. REQUIRED INSURANCE AND LIMITS

The insurance policies shall provide the minimum coverages and limits set forth below. Providing coverage in these stated minimum limits shall not be construed to relieve Contractor from liability in excess of such limits.

3.1 Commercial General Liability Insurance

Contractor shall maintain Commercial General Liability Insurance policy with limits not less than One Million Dollars (\$1,000,000) each occurrence and Two Million Dollars (\$2,000,000) annual aggregate. This policy shall be written on ISO form CG 00 01 04 13 or its equivalent and shall include product liability especially when a Contract is solely for purchasing supplies. It includes Products and Completed Operations for three years following the completion of work related to performing construction services. It shall be endorsed to include: A per project aggregate policy limit (using ISO form CG 25 03 05 09 or equivalent endorsement)

3.2 Commercial (Business) Automobile Liability Insurance

Contractor shall maintain Commercial Automobile Liability policy with limits not less than One Million Dollars (\$1,000,000) each accident for bodily injury and property damage and bodily injury and property damage coverage for owned (if any), non-owned, hired, or leased vehicles. Commercial Automobile Liability Insurance shall be written using ISO form CA 00 01 or equivalent. Contractor must also maintain MCS 90 and CA 99 48 endorsements or equivalent if "Pollutants" are to be transported unless in-transit Pollution coverage is covered under required Contractor's Pollution Liability Insurance.

3.3 Workers' Compensation

Contractor shall comply with Workers' Compensation coverage as required by the Industrial Insurance laws of the State of Washington, as well as any other similar coverage required for this work by applicable federal laws of other states. Contractor must comply with their domicile State Industrial Insurance laws if it is outside the State of Washington.

3.4 Employers' Liability Insurance

Contractor shall maintain Employers' Liability coverage with limits not less than One Million Dollars (\$1,000,000) each employee, One Million Dollars (\$1,000,000) each accident, and One Million Dollars (\$1,000,000) policy limit.

3.5 Media Liability Insurance

Contractor shall maintain Media Liability coverage with limits not less than One Million Dollars (\$1,000,000) each claim and One Million Dollars (\$1,000,000) aggregate. Coverage shall include but not be limited to defamation, disparagement, libel, slander, invasion of privacy, infringement of title, slogan, trademark, trade name, trade dress, service mark or service name, infringement of copyright and plagiarism.



3.6 Other Insurance

Other insurance may be deemed appropriate to cover risks and exposures related to the scope of work or changes to the scope of work required by City of Tacoma. The costs of such necessary and appropriate Insurance coverage shall be borne by Contractor.
