NOTICE TO ALL BIDDERS:

This addendum is issued to clarify, revise, add to or delete from, the original specification documents for the above project. This addendum, as integrated with the original specification documents, shall form the specification documents. The noted revisions shall take precedence over previously issued specification documents and shall become part of this contract.

REVISIONS TO THE SUBMITTAL DEADLINE:

The submittal deadline has been changed to 11:00 a.m., Pacific Time, Tuesday, December 27, 2022.

REVISIONS TO THE SPECIAL PROVISIONS:

Change No. 1 – Supplement Section 7-05.3 with the following:

“City will provide Contractor with manhole ring and covers for installation. Contractor will be responsible for picking up the castings at the following location:

Tacoma Central Treatment Plant
2201 Portland Avenue E.
Tacoma, WA 98421

Contractor will be responsible for securing, storing, and protecting the castings after picking them up from Tacoma Central Treatment Plant. Any castings that are stolen, lost, or damaged while in possession of the Contractor shall be replaced by the Contractor at no expense to the City.”

Change No. 2 – Revise the payment description for “Manhole_____” in Section 7-05.5 as follows:

“The unit contract price for “Manhole_____” shall be full pay for all work required to furnish and install the new manhole to finished grade, including, but not limited to, excavating for, furnishing backfill, compaction of backfill, connection of new pipe(s), channeling, ~~covers, frames,~~ ladders, steps, and handholds, as applicable per standard Plans.”

Change No. 3 – Revise the payment description for “Adjust Existing Manhole, Furnish New Frame and Cover” in Section 7-05.5 as follows:

“The unit contract price per each for “Adjust Existing Manhole, Furnish New Frame and Cover” shall be full pay for all costs associated with adjusting the frame and cover to finished grade, including but not limited to, excavating, furnish and place backfill, ~~furnishing and~~ installing the new frame and cover, compacting, surfacing, and restoration.”

Change No. 4 – Supplement Section 7-05.5 with the following:

“All costs for coordinating with City staff; picking up manhole castings; and securing, storing, and protecting castings shall be included in the unit price for “Manhole_____” and “Adjust Existing Manhole, Furnish New Frame and Cover””

REVISIONS TO THE TECHNICAL PROVISIONS:

REVISIONS TO THE PLANS:

Replace the following plan sheets in their entirety with the attached sheets: 14, 17, 19, 20, 21, 22, 24, 41, 42.

On sheets 14, 17, 20, 21, 22 and 24, the differences include changes to Construction Note 2 and the associated construction limits described in the profiles, and addition of Construction Notes 52 and 53 and associated construction limits described in the profiles.

On sheet 19, the differences include shifting the stationing callouts for the beginning of curb to correctly correspond to the edge of pavement on the western extent of the intersection.

On sheet 41, the differences include additional details 1, 2 and 3, and changes to stationing in applicable roadway sections

On sheet 42, the differences include changes to the roadway sections and changes to stationing in applicable roadway sections

REVISIONS TO THE PROPOSAL PAGES:

The following proposal item quantities have been revised: R9, R19, R24, R25

- R9, Roadway Excavation, Incl. Haul – Quantity has been revised from 4,855 Cu. Yd. to 5,005 Cu. Yd.
- R19, Crushed Surfacing Top Course – Quantity has been revised from 70 Ton to 320 Ton
- R24, Fiber Reinforced HMA Cl. 1/2" PG 58H-22 for Pavement Patch – Quantity has been revised from 165 Ton to 25 Ton
- R25, Fiber Reinforced HMA Cl. 1/2" PG 58H-22 – Quantity has been revised from 890 Ton to 1,190 Ton
