- Question 1: Will you consider extending the bid date, by at least a week, for this project? The large scale of this project, and the fact that most suppliers/contractors will be off next week for the Holiday, will make it extremely difficult to complete a quote by November 29th
- Answer 1: The submittal deadline has been changed to 11:00 a.m., Pacific Time, Tuesday, December 13th, 2022.
- Question 2: Can you please tell me if there are any federal funds on this project, and if so, do any Buy America standards apply?
- Answer 2: This project does not include federal funds and the Build America Buy America (BABA) requirements do not apply.
- Question 3: The Specs call for Builder's Risk Insurance. Does this insurance really apply to this project?
- Answer 3: Builder's Risk Insurance is not needed for this project. Please reference Addendum No. 03
- Question 4: Bid item WW95: Ductile Iron Sewer Pipe 6" Diam. is it your intent that the side sewer located within 10' of a water service be constructed from Ductile Iron? Plan sheet 30, General Note 3, states that side sewer shall be constructed from PVC.

Answer 4: Reference Addendum No. 03. Side sewer pipe located within 10' of a water service shall be solid wall PVC pressure pipe meeting the requirements of Section 9-30.1(5)A.
