**Question 1:** We are contacting you to see if this project is actually going to be bid 7/5/22 the day after 7/4/22, this is going to be tough to get good competitive numbers to turn in a bid being right before a long holiday weekend. Will this bid date be pushed with an addenda to reflect this?

Answer 1: Addendum 1 has been issued to extend the submittal deadline to July 12, 2022.

**Question 2:** I was hoping you could help me with what the liquidated damages are for this project. I'm not seeing a dollar per day amount in the special provisions or the standard specifications.

Answer 2: Liquidated Damages value can't be established until the original bid has been accepted, based on the WSDOT formula in Section 1-08.9 which states:  
**Liquidated Damages Formula**

$$LD=0.15C/T$$

Where:

LD = liquidated damages per working day (rounded to the nearest dollar)

C = original Contract amount

T = original time for Physical Completion

## DESCRIPTION OF WORK

This Contract shall generally consist of rehabilitating approximately 9,811 linear feet of 8-inch to 48-inch diameter wastewater sewer pipes utilizing cured-in-place pipe technology. This Work shall also include cleaning sewer pipes, disposing of waste materials, and performing CCTV inspections of the sewer pipes.
