6.1 Equipment Requirements: An all-weather jacket capable for withstanding and providing protection for first responders in the Pacific Northwest.

- 6.2.2 Sizing: Men's and Woman's sizes with the option for additional sizes in Tall/Long

- 6.2.3 Stowable or removable hood

8. IMPORTANT INFORMATION

- 8.1 Vendors can submit multiple jackets per submittal.
- **8.2** After the submittal is closed, TFD will contact each vendor to schedule a demonstration time. Vendors will be allotted a 30 minute per coat timeframe to present the jackets to the committee, with a maximum of 2 hours per agency. We anticipate the demonstration day to be, Monday November 15.
- **8.3** It is likely that these demonstrations will be provided virtually.
- 8.4 TFD would like to have at least one (1) jacket in each size Medium, Large and Extra Large for the committee to look at in person in two weeks before the demonstrations, so delivery by October 29. Jackets can be mailed or hand delivered to our Fire Garage at 3401B South Orchard, Tacoma WA 98466-6826. Jackets will be returned to vendors either via mail or can be picked up after the demonstration day.

9. INSURANCE

With virtual demonstrations, it is not anticipated there will be any insurance requirements. If that changes and vendors attend demonstrations on site, they will need to provide a COI with shows a minimum of:

Contractor shall maintain Commercial General Liability Insurance policy with limits not less than One Million Dollars (\$1,000,000) each occurrence and Two Million Dollars (\$2,000,000) annual aggregate. The Commercial General Liability Insurance policy shall be written on an Insurance Services Office form CG 00 01 04 13 or its equivalent. Products and Completed Operations shall be maintained for a period of three years following Substantial Completion of the Work related to performing construction services.

• A per project aggregate policy limit, using ISO form CG 25 03 05 09 or an equivalent endorsement.

10. ENVIRONMENTALLY PREFERABLE PROCUREMENT
