Request for Information

Purpose

This document provides ample information for vendors to decide whether they're willing to participate in a more detailed selection process. Issuing this request in no way obligates the City of Tacoma to include any of the replying vendors in the future selection process. It will enable the vendors to provide sufficient information for City of Tacoma to select a shortlist of vendors which may be included in the Request for Proposal (RFP).

Vendors do not need to, and are encouraged not to, prepare detailed proposals at this stage. Vendors should provide basic information regarding capabilities and an indication as to how they would approach working with City of Tacoma to achieve this document's outlined objectives.

About the City of Tacoma

The City of Tacoma is a local government entity located in Pierce County along the southern end of Puget Sound in Washington. COT employs approximately 4,000 employees, and over 200,000 citizens. The City of Tacoma is unique in that it owns a Power and Water utility, a railway, and a seaport. Departments with the City of Tacoma include Public Works, Planning and Development Services, Environmental Services, as well as Libraries, Parks, Fire, Police, and more. We provide citizens and businesses with permits, inspections, parking enforcement, and many other services.

Project Details

Project DeepSea Details

Project **DeepSea** is a technology modernization project aimed at replacing and improving upon functionality that stores and allows searches of millions of digital images of land use drawings, permits, inspection records, and other important engineering artifacts that the City of Tacoma is charged with preserving. The project team will be responsible for converting existing files from TIFF format into PDF to improve usability and searching.

It is important that the project address the business needs related to geospatial data and mapping requirements, records management policies, storage and organization efficiencies, and the creation of a streamlined process for scanning new drawings and documents into the system in such a way that related files may be cross-referenced and indexed along with the new scans.



Project Scope

Project **DeepSea** may require project management for the implementation of the new solution. It will involve installation, configuration, data transformation and migration, content management, training, and post-implementation support¹.

Business Goals

- Provide public with access to digital records for property and land use drawings, permits, inspections, and other
 official documents and public records.
- Archive drawings for future reference.
- Easily and quickly search and retrieve all drawings and documents related to a specific address or set of coordinates.
- Protect sensitive information such as City facility drawings from exposure to the public for safety reasons.
- Provide evidentiary materials to City Counsel for litigation or defense of the City's interests and/or property.
- Provide non-government agencies and public utilities access to search for drawings and documents.

Business Requirements

Below are the top desired features:

- Provide a means for scanning and indexing new large scale drawings and documents.
- Improve searching of drawings and documents using metadata, barcodes, geography or content type.
- Allow ingestion of drawings electronically from Auto-CAD.
- Allow ingestion of drawings electronically from ArcPro.
- Allow integration with GIS tools for mapping documents with geospatial data.
- Enable integration with Open Data sources.
- Ensure the safe digital storage of one-of-a-kind, historically important drawings and documents in perpetuity.
- Prevent duplication of drawings and documents to reduce redundancy.
- Allow consolidation of multiple related files when printing.
- Version control & back-up / restore capabilities.
- Editable drawings for markup, signatures, and notaries.
- Allow break down of drawing sets into layers (i.e. Floors, elevation, site plans, floor plans, etc.)
- Integrates with DocuSign
