1. BACKGROUND

Tacoma Water is seeking proposals for providing routine hauling services for material generated as a byproduct of the water treatment operations at the Green River Filtration Facility (GRFF). The water filtration residual cake will be dewatered to approximately 18-30% solids by screw presses and is loaded by conveyor into containers. The cake will consist of silts, clays and organics that are filtered out of the river water as well as coagulants and polymers added during the treatment process. The material produced has been tested and identified as non-hazardous.

Hauler shall transport the cake from the GRFF to Tacoma Water's contracted disposal site, or an alternative certified disposal site owned or contracted by the hauler and approved by Tacoma Water.

The City anticipates awarding two contracts: A primary hauling contract and a backup hauling contract through 12/31/2024 with the option to renew up to three additional one-year periods. Award of the primary hauler and backup hauler will be based on the evaluation by a Selection Advisory Committee (SAC). The scoring criteria can be found in Section 10 of this RFP. More details about the backup hauler's scope of services can be found in Section 1 of the Technical Specifications in Appendix A.

2. MINIMUM REQUIREMENTS

Hauler shall provide CDL licensed, experienced drivers/equipment operators and a truck/trailer capable of loading and carrying Tacoma Water's 20-foot long, 22-cubic yard roll off containers with a combined cake and container weight up to 45,000 pounds or proposed alternate containers owned by the proposer that will fit within a loading bay, approximately 8-10 feet wide inside the 14-foot tall doorway.

Hauler shall maintain all appropriate insurance, permits, licenses and approvals as may be required to haul municipal water filtration residual cake. Minimum City of Tacoma insurance requirements are attached to this RFP (Appendix C).

Tacoma Water will ensure that the material to be hauled is acceptable for disposal at the designated location. Tacoma Water will not require Hauler to haul material that will not pass a paint filter test as outlined in <u>EPA Method 9095B – Paint Filter Liquids Test</u>.

Hauler shall be fully responsible for the safe delivery of the material in accordance with all local, state, and federal laws as well as the requirements stated within this proposal document. Hauler shall be responsible for ensuring that the load is tarped and secured.

3. SCOPE OF SERVICES AND DELIVERABLES

It is the City's intent to select a firm based on qualifications and abilities of the proposer.

Work shall be on an "as needed" basis according to the operation of the GRFF, and subject to any scheduling limitations of the disposal site. There is no minimum demand for service or guaranteed amount of work.

An estimated 3000 tons/year of water filtration residual cake is generated at the GRFF. The actual number of tons per year may increase or decrease according to operation of the GRFF. Hauling trips will be coordinated on an as-needed basis by GRFF operators.

4. CONTRACT TERM

The initial contract will be through 12/31/2024 with the option to renew the contract for three additional one-year periods. The City reserves the right to cancel the contract for any reason, by written notice, as stipulated in the contract.

5. CALENDAR OF EVENTS

This is a tentative schedule only and may be altered at the sole discretion of the City.

Contract may be issued after Public Utility Board and/or City Council approval.

9. EVALUATION CRITERIA

The SAC will review and evaluate submittals. After the evaluation, the SAC may conduct interviews of the most qualified proposers before final selection.

- **9.1** The SAC will select a primary hauler and backup hauler from the respondents to provide the services required.
- **9.2** The City reserves the right to visit facilities of selected Respondents for the purpose of confirming qualifications and understanding proposed alternatives.
- **9.3** The SAC may use references to clarify information in the submittals and interviews, if conducted, which may affect the rating. The City reserves the right to contact references other than those included in the submittal.
- **9.4** A significant deficiency in any one criteria is grounds for rejection of the submittal as a whole.
- **9.5** The City reserves the right to deny any proposal that would be incompatible with GRFF operations.

10. CONTENT TO BE SUBMITTED

A full and complete response to each of the "CONTENT TO BE SUBMITTED" items is expected in a single location; do not cross reference to another section in your submittal.

Submittals should present information in a straightforward and concise manner, while ensuring complete and detailed descriptions of the respondent's/team's abilities to meet the requirement of this RFP. Emphasis will be on completeness of content. The written submittals should be prepared in the sequential order as outlined below.

The City reserves the right to request clarification of any aspect of a firm's submittal, or request additional information that might be required to properly evaluate the submittal. A firm's failure to respond to such a request may result in rejection of the firm's submittal. Firms are required to provide responses to any request clarification within two (2) business days.

10.1 Overall Price – 40 points

Information provided by the proposer for line items 1-6 shall be the basis for evaluating the overall price per ton. The value shall include all fees, trucking costs, fuel, overhead, etc. for performing the work. Proposers are not required to respond to every line item and should strikethrough any line item number they do not want to be evaluated on.

The proposer with the lowest overall price per ton for line items 1-6 will be awarded maximum points for this section. The overall per ton price for Tacoma Water will be calculated as follows:

Overall Price (\$ per ton) = (\$ Cost per Trip) / (Est. Tons per Trip) + (Disposal Cost per Ton)

10.2 Proposal To Provide Services – 30 points

11. INTERVIEWS / ORAL PRESENTATIONS

An invitation to interview may be extended to Respondents based on SAC review of the written submittals. The SAC reserves the right to adjust scoring based on additional information and/or clarifications provided during interviews. The SAC may determine additional scoring criteria for the interviews following evaluation of written submittals.

The City reserves all rights to begin contract negotiations without conducting interviews.

Respondents must be available to interview within three business days notice.

If interviews are conducted, the SAC will schedule the interviews with the contact person provided in the SOQs. Additional interview information will be provided at the time of invitation.

12. RESPONSIVENESS

Respondents agree their submittal is valid until a contract(s) has been executed.

All submittals will be reviewed by the City to determine compliance with the requirements and instructions specified in this RFP. The Respondent is specifically notified that failure to comply with any part of this RFP may result in rejection of the submittal as non-responsive. The City reserves the right, in its sole discretion, to waive irregularities deemed immaterial.

The final selection, if any, will be that submittal which, after review of submissions and potential interviews, in the sole judgement of the City, best meets the requirements set forth in this RFP.

13. ACCEPTANCE / REJECTION OF SUBMITTALS

Respondents are advised that the City reserves the right to cancel award of this Contract at any time before execution of the Contract by both parties if cancellation is deemed to be in the City's best interest. In submitting a Submittal, Respondents agree that the City is not liable for any costs or damages for the cancellation of an award.

The City reserves the right and holds at its discretion the following rights and options:

- To waive any or all informalities
- To award one or more contracts
- To not award a contract
- To issue subsequent solicitation

14. ACCEPTANCE OF SUBMITTAL CONTENTS

The Submittal contents of the successful Respondent will become contractual obligations if a contract ensues.

15. CONTRACT OBLIGATION

The selected Respondent(s) will be expected to execute a contract with the City. As part of the negotiation process, Respondents may propose amendments to the contract, but the City, at its sole option, will decide whether to open discussion on each proposed amendment and determine the final contract to be used. At a minimum, any contract will incorporate the terms and conditions contained herein.

16. STANDARD TERMS AND CONDITIONS / GENERAL PROVISIONS

City of Tacoma Standard Terms and Conditions apply.

17. INSURANCE REQUIREMENTS

Successful proposer will provide proof of and maintain the insurance coverage in the amounts and in the manner specified in the City of Tacoma Insurance Requirements contained in this solicitation. Please see Appendix C.

18. PREVAILING WAGE INFORMATION

This project requires prevailing wages under <u>39.12 RCW</u>. Any worker, laborer, or mechanic employed in the performance of any part of the work shall be paid not less than the applicable prevailing rate of wage.

The project site is located in King County.

The effective date for prevailing wages on this project will be the **submittal deadline** with these exceptions:

- a. If the project is not awarded within six months of the submittal deadline, the award date is the effective date.
- b. If the project is not awarded pursuant to a competitive solicitation, the date the contract is executed is the effective date.
- c. Janitorial contracts follow WAC 296-127-023.

Except for janitorial contracts, these rates shall apply for the duration of the contract unless otherwise noted in the solicitation.

The contractor and all subcontractors covered under <u>39.12 RCW</u> shall submit to the Department of Labor and Industries (L&I) for work provided under this contract:

2. An Affidavit of Wages Paid must be filed with and approved by L&I upon job completion.

Payments cannot be released by the City until verification of these filings are received by the engineer. 19. PAID LEAVE

20. PARTNERSHIPS

The City will allow firms to partner in order to respond to this RFP. Respondents may team under a Prime Respondent's submittal in order to provide responses to all sections in a single submission; however, each Respondent's participation must be clearly delineated by section. The Prime Respondent will be considered the responding vendor and the responsible party at contract award. All contract negotiations will be conducted only with the Prime Respondent. All contract payments will be made only to the Prime Respondent. Any agreements between the Prime Respondent and other companies will not be a part of the agreement between the City and the Prime Respondent. The City reserves the right to select more than one Prime Respondent.

21. AWARD

After the Respondents are selected by the SAC and prior to award, all other Respondents will be notified via email by the Purchasing Division.

Once a finalist (or finalists) has been selected by the Selection Advisory Committee, contract negotiations with that finalist will begin, and if a contract is successfully negotiated, it will, if required, be submitted for final approval by the Public Utility Board and/or City Council.

22. ENVIRONMENTALLY PREFERABLE PROCUREMENT

In accordance with the <u>City's Sustainable Procurement Policy</u> and <u>Climate Action Plan</u>, it is the policy of the City of Tacoma to encourage the use of products or services that help to minimize the environmental and human health impacts of City Operations. TECHNICAL SPECIFICATIONS

These technical specifications cover the contracted service of hauling water filtration residual cake for the City of Tacoma, Department of Public Utilities, Water Division (Tacoma Water). All pricing shall include the costs of proposal preparation, servicing of accounts, and all contractual requirements.

1. HAULING FREQUENCY

Tacoma Water will typically give notice to Hauler at least 2 business days prior to hauling services being required; however, Hauler shall have sufficient resources to be capable of scheduling and making appropriate equipment and personnel available in as little as 24 hours after notice that a load must be hauled. Failure to meet agreed-upon pick up times may result in Tacoma Water utilizing the backup hauler contract. Tacoma Water, at its sole discretion, reserves the right to discontinue use or terminate the Hauler contract if ongoing delays continue.

Tacoma Water may require up to 4 loads to be hauled per day during atypical water quality events. If Hauler does not have sufficient resources available to keep up with hauling demand at any time, Tacoma Water reserves the right to utilize the backup hauler to haul the additional loads.

A. Backup Hauler Scope of Services

The Backup Hauler will be called upon if the Primary Hauler cannot meet the normal demands of the loads generated by the GRFF due to equipment downtime, staffing shortages or any other delays by the Primary Hauler. It is anticipated that the Backup Hauler may be needed to haul 24 trips/year to Tacoma Water's designated disposal site and approximately 4 trips/year to dispose of solids into the sludge storage basin. The number of trips per year by the Backup Hauler are subject to change and are dependent on circumstances. There is no guarantee of number of trips or timing of need for the services of the Backup Hauler.

Hauler is expected to do its best to anticipate and prepare for Tacoma Water's hauling needs. Hauler shall acknowledge the criticality of the service of hauling water filtration residual cake in order to ensure no interruptions to the water filtration process that is critical to providing safe drinking water to the public and shall make its best effort to ensure timely hauling services. Hauler shall be onsite to load solids within 2 business days or less of verbal notification by Tacoma Water.

2. <u>SEASONAL OPERATIONAL CHANGES</u>

When the screw presses are not in operation, typically in the spring/summer months (June-Sept), Tacoma Water may transfer the process stream into the Sludge Storage Basin to dry.

After the solids have dried in the Sludge Storage Basin, Tacoma Water staff fill the containers with the material using a backhoe owned by Tacoma Water.

Tacoma Water will coordinate with the Hauler to pick up the filled containers of dried solids in the Sludge Storage Basin.

Hauler will drive into the Sludge Storage Basin adjacent to the solids handling building and return the empty containers to an appropriate location designated by Tacoma Water staff within the basin itself.

A detailed drawing and layout of the Sludge Storage Basin can be seen in Exhibit D (Appendix A). One to ten loads are expected to be hauled out of the Sludge Storage Basin per year.

In the event that the screw presses are not running optimally, Tacoma Water may also ask the hauler to dump the containers into the Sludge Storage Basin onsite, rather than drive them to a disposal site. One to ten loads are estimated to be disposed of in the Sludge Storage Basin per year.

Tacoma Water will typically schedule loads to be picked up Monday through Friday between 6:00 am and 6:00 pm, Pacific Time; however, atypical water quality events may require hauling outside of these normal business hours and days. Times for pickup of containers are flexible at the GRFF but are primarily driven by the disposal site's hours of operation. No overtime fees or surcharges will be paid to the Hauler; payments will be made according to the unit price per trip, even if hauling is performed outside of normal business hours. See the Section 7 Payment for more information.

Proposer shall base their proposal price on the estimated seasonal demands as follows:

May through October: roughly 2-4 loads/week

November through April: roughly 4-6 loads/week, with higher demand during rain storm events.

These rates are estimated to result in approximately 3000 tons/year.

3. CONTAINERS FOR HAULING

Tacoma Water requires Proposer to provide their maximum Gross Vehicle Weight (GVW) rating and combined weight of their truck and trailer. Tacoma Water will monitor and fill the containers to a weight that will not exceed the hauler's maximum GVW. The truck and trailer shall be owned and maintained by the hauler.

Proposer may propose the use of their own containers as an alternate proposal for Tacoma Water's consideration. Proposer may include pricing for both options in their proposal. Tacoma Water reserves the right to contract for the option it deems most preferable. Additional information about the two options for containers is included in the following sections.

A). Utilization of Tacoma Water's 22-Cubic Yard (CY) Containers:

Tacoma Water owns six 22-CY containers available for the hauler to use given the hauler has the proper equipment to handle this type of container. A maximum weight of 20 tons of dewatered solids may be loaded into them. Detailed drawings of the 22-CY container can be seen in Exhibit A (Appendix A).

Hauler shall be responsible for loading the filled containers onto the trailer at the GRFF and for emptying the containers at the disposal site, and then immediately returning the empty containers to the GRFF. Hauler may coordinate with Tacoma Water to temporarily store one container owned by Tacoma Water at their facility after disposing of the material to eliminate the need for a return trip to the GRFF on the same day.

Hauler shall be liable for any damage to Tacoma Water containers while in transport, at the disposal site, and stored at their facility and shall not use the containers for any other purpose. Upon request from Tacoma Water, Hauler shall return the empty container within 1 business day, even if no hauling is scheduled. The Hauler must return the Tacoma Water-owned container upon the contract end date. Upon returning the empty container at the GRFF, Hauler shall place the container in the location behind the Mechanical Dewatering Building or onsite as directed by Tacoma Water staff.

B). Other Containers as Proposed

Proposer may propose to provide their own containers for Tacoma Water to fill with solids from the screw press. The proposed containers will need to fit within a loading bay, approximately 8-10 feet wide inside the 14-foot tall doorway. Additional details about the location of the container within the loading bay can be found in Exhibit B (Appendix A). Additional details about the site layout can be found in Exhibits C and D Appendix A). Details can also be seen in person during the site visit.

When Hauler is called upon to pick up the next load of filled containers, Hauler will bring empty containers and exchange them for the filled containers at the GRFF. Upon returning the empty containers to the GRFF, Hauler shall replace the containers in the appropriate location onsite as directed by Tacoma Water.

Upon scheduling by Tacoma Water, the filled containers shall be picked up at the GRFF by the hauler and shall be hauled to and dumped at the disposal location. The empty containers shall then be returned to the GRFF by the hauler on the same day. The frequency of required hauling is estimated to be one to six loads per week, as dictated by water treatment operations throughout the duration of the contract.

Upon arrival at the GRFF, Hauler shall check in with the GRFF operator on duty and shall not commence connecting to or moving the container until instructed by the operator.

4. DISPOSAL SITE

Tacoma Water currently has a contract with Regional Disposal dba Republic Services for disposal at the transfer station located at 2733 3rd Ave S Seattle, WA 98134. Tacoma Water will maintain appropriate approvals with disposal location managers and will be responsible for payment.

Tacoma Water also has approval to dispose of solids at the Cedar Hills Regional Landfill located at 16645 228th Avenue SE, Maple Valley, WA 98038 as a backup to the Regional Disposal site.

With Tacoma Water approval, the hauler may dispose of solids at a certified disposal site owned or contracted by the hauler. Details about price per ton and location of the proposed alternate disposal must be included on the proposal cost worksheet.

If proposing to use an alternate disposal site other than the sites listed above, the following minimum criteria must be met:

- The disposal site shall be constructed to allow the entire operation to proceed in a safe and efficient manner, and to allow off-load of entire contents of each truck at one location, followed by quick exit from the facility. Access and exit must be via arterial streets with minimal or no interstate traffic.
- The proposed disposal site shall be categorized as a Subtitle D landfill and provide a list
 of any physical characteristics and or maximum allowable limits that would make the
 waste unacceptable due to the method of waste management. The list shall become a
 part of the Contract and shall only be changed with prior written consent of Purchasing.
- The proposed disposal site shall acknowledge receipt and weight of each load of
 material sent by City Department. Copies of each Receipt shall be sent to the City
 Department's designated representative for its records, along with an invoice. Each
 invoice shall include the City Department name and/or the City hauler name, truck name
 (or #), date, time of delivery, and total weight of accepted waste.
- Custody to the wastes shall immediately pass to the hauler at time of pick up from the City generating location.
- The City may visit and view all facilities and equipment used or proposed to be used in the performance of the Contract, including Contractor's facilities and those of any subcontractor. Such visits may occur at any time after submittal and prior to awarding the Contract, or during the Contract term.

Tacoma Water will present Hauler with a manifest for each load documenting its contents and its approval for acceptance at the disposal location. The hauler shall obtain a weight ticket or documentation of disposal at the disposal location for billing and invoicing purposes and shall return the ticket to Tacoma Water upon container return.

If the hauler decides to temporarily store a Tacoma Water-owned container at their facility, the hauler will immediately send (via email) the weight ticket information to Tacoma Water upon returning to their facility.

5. COMPLIANCE

Hauler shall observe and comply with all ordinances, laws, requirements, and regulations of all units of government and governmental agencies having jurisdiction over any aspect of the handling and transporting of the material. Hauler shall protect and indemnify Tacoma Water, the City of Tacoma and any of their officers and agents against any claim or liability arising from or based on any violation of the same.

If Hauler has a concern about the integrity of the container and door seal of the containers, Hauler shall raise this concern and find a suitable solution with Tacoma Water staff prior to loading and transporting the load.

Hauler shall be responsible and liable for any damage to property and equipment owned by Tacoma Water during loading, hauling, and unloading, specifically, the roll-off container and its tarped cover, the surrounding asphalt area, and the building in which the container is being loaded.

6. SPILL RESPONSE

Hauler shall be responsible and liable for cleaning up or remedying any accident or spill that occurs during loading of the container onto the trailer or during transportation. For any spills onsite at the GRFF, Hauler shall immediately notify onsite Tacoma Water personnel and begin cleanup. If Hauler has not initiated a response within four (4) hours, the spill may be cleaned up under the direction of Tacoma Water personnel with all costs – including first response and clean-up fees, fines or penalties that may be imposed by regulating authorities, and \$150.00 per hour for each hour that Tacoma Water personnel must be engaged in the clean-up process – reimbursed by Hauler. Hauler agrees to pay and/or authorize Tacoma Water to deduct from any sum due or to be due to Hauler such spill-related costs.

7. PAYMENT

Payments to Hauler will be made regularly against invoices submitted by the hauler for loads hauled according to the rates furnished by Hauler as part of this proposal process. The total price charged to Tacoma Water shall be the product of the unit price per trip and the number of trips charged on that particular invoice. No other fees or surcharges (including fuel surcharges or any other surcharges) shall be billed to Tacoma Water.

Invoices shall be submitted by email or through the City of Tacoma's payment system. Upon contract award, Hauler shall obtain current contact information from Tacoma Water for submitting invoices.

Invoices shall include the unique identification number listed on the manifest for the load(s) hauled, the order number given by the hauler, the date and time that the load was picked up at the GRFF, and the contracted price.

NOTE: Incomplete invoicing will not be accepted; vendor will be required to correct and resubmit.

FEDERAL FUNDING

1. COPELAND ANTI-KICKBACK ACT

For Contracts subject to Davis Bacon Act the following clauses will be incorporated into the Contract:

In the event of CONTRACTOR's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this Contract may be canceled, terminated, or suspended in whole or in part and the CONTRACTOR may be declared ineligible for further federally funded contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- H. CONTRACTOR will include the portion of the sentence immediately preceding paragraph (A) and the provisions of paragraphs (A) through (G) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. CONTRACTOR will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance:

This Insurance Requirements shall serve as an attachment and/or exhibit form to the Contract. The Agency entering a Contract with City of Tacoma, whether designated as a Supplier, Contractor, Vendor, Proposer, Bidder, Respondent, Seller, Merchant, Service Provider, or otherwise referred to as "Contractor".

1. GENERAL REQUIREMENTS

The following General Requirements apply to Contractor and to Subcontractor(s) performing services and/or activities pursuant to the terms of this Contract. Contractor acknowledges and agrees to the following insurance requirements:

- 1.1. Contractor shall not begin work under the Contract until the required insurance has been obtained and approved by the City of Tacoma.
- 1.2. Contractor shall keep in force during the entire term of the Contract, at no expense to the City of Tacoma, the insurance coverage and limits of liability listed below and for Thirty (30) calendar days after completion of all work required by the Contract, unless otherwise provided herein.
- 1.3. Liability insurance policies, except for Professional Liability and Workers' Compensation, shall:
 - 1.3.1. Name the City of Tacoma and its officers, elected officials, employees, and agents as additional insured
 - 1.3.2. Be considered primary and non-contributory for all claims with any insurance or selfinsurance or limits of liability maintained by the City of Tacoma
 - 1.3.3. Contain a "Waiver of Subrogation" clause in favor of City of Tacoma
 - 1.3.4. Include a "Separation of Insureds" clause that applies coverage separately to each insured and additional insured
 - 1.3.5. Name the "City of Tacoma" on certificates of insurance and endorsements and not a specific person or department
 - 1.3.6. Be for both ongoing and completed operations using Insurance Services Office (ISO) form CG 20 10 04 13 and CG 20 37 04 13 or the equivalent
 - 1.3.7. Be satisfied by a single primary limit or by a combination of a primary policy and a separate excess umbrella
- 1.4. A notation of coverage enhancements on the Certificate of Insurance shall not satisfy these requirements below. Verification of coverage shall include:
 - 1.4.1. An ACORD certificate or equivalent
 - 1.4.2. Copies of requested endorsements
- 1.5. Contractor shall provide to City of Tacoma Procurement & Payable Division, prior to the execution of the Contract, Certificate(s) of Insurance and endorsements from the insurer certifying the coverage of all insurance required herein. Contract or Permit number and the City of Tacoma Department must be shown on the Certificate of Insurance.

- 1.6. A renewal Certificate of Insurance shall be provided electronically prior to coverage expiration via email sent annually to coi@cityoftacoma.org.
- 1.7. Contractor shall send a notice of cancellation or non-renewal of this required insurance within Thirty (30) calendar days to coi@cityoftacoma.org.
- 1.8. "Claims-Made" coverages, except for pollution coverage, shall be maintained for a minimum of three years following the expiration or earlier termination of the Contract. Pollution coverage shall be maintained for six years following the expiration of the Contract. The retroactive date shall be prior to or coincident with the effective date of the Contract.
- 1.9. Each insurance policy must be written by companies licensed or authorized (or issued as surplus line by Washington surplus line broker) in the State of Washington pursuant to RCW 48 with an (A-) VII or higher in the A.M. Best key rating guide.
- 1.10. Contractor shall not allow any insurance to be cancelled, voided, suspended, or reduced in coverage/limits, or lapse during any term of this Contract. Otherwise, it shall constitute a material breach of the Contract.
- 1.11. Contractor shall be responsible for the payment of all premiums, deductibles and self-insured retentions, and shall indemnify and hold the City of Tacoma harmless to the extent such a deductible or self-insured retained limit may apply to the City of Tacoma as an additional insured. Any deductible or self-insured retained limits in excess of Twenty Five Thousand Dollars (\$25,000) must be disclosed and approved by City of Tacoma Risk Manager and shown on the Certificate of Insurance.
- 1.12. City of Tacoma reserves the right to review insurance requirements during any term of the Contract and to require that Contractor make reasonable adjustments when the scope of services changes.
- 1.13. All costs for insurance are included in the initial Contract and no additional payment will be made by City of Tacoma to Contractor.
- 1.14. Insurance coverages specified in this Contract are not intended and will not be interpreted to limit the responsibility or liability of Contractor or Subcontractor(s).
- 1.15. Failure by City of Tacoma to identify a deficiency in the insurance documentation or to verify coverage or compliance by Contractor with these insurance requirements shall not be construed as a waiver of Contractor's obligation to maintain such insurance.
- 1.16. If Contractor is a government agency or self-insured for any of the above insurance requirements, Contractor shall be liable for any self-insured retention or deductible portion of any claim for which insurance is required. A certification of self-insurance shall be attached and incorporated by reference and shall constitute compliance with this Section.

2. SUBCONTRACTORS

It is Contractor's responsibility to ensure that each subcontractor obtain and maintain adequate liability insurance coverage that applies to the service provided. Contractor shall provide evidence of such insurance upon City of Tacoma's request. Failure of any subcontractor to comply with insurance requirements does not limit Contractor's liability or responsibility.

3. REQUIRED INSURANCE AND LIMITS

The insurance policies shall provide the minimum coverages and limits set forth below. Providing coverage in these stated minimum limits shall not be construed to relieve Contractor from liability in excess of such limits.

3.1 Commercial General Liability Insurance

Contractor shall maintain Commercial General Liability Insurance policy with limits not less than One Million Dollars (\$1,000,000) each occurrence and Two Million Dollars (\$2,000,000) annual aggregate. This policy shall be written on ISO form CG 00 01 04 13 or its equivalent and shall include product liability especially when a Contract is solely for purchasing supplies. It includes Products and Completed Operations for three years following the completion of work related to performing construction services. It shall be endorsed to include: A per project aggregate policy limit (using ISO form CG 25 03 05 09 or equivalent endorsement)

3.2 Commercial (Business) Automobile Liability Insurance

Contractor shall maintain Commercial Automobile Liability policy with limits not less than One Million Dollars (\$1,000,000) each accident for bodily injury and property damage and bodily injury and property damage coverage for owned (if any), non-owned, hired, or leased vehicles. Commercial Automobile Liability Insurance shall be written using ISO form CA 00 01 or equivalent. Contractor must also maintain MCS 90 and CA 99 48 endorsements or equivalent if "Pollutants" are to be transported unless in-transit Pollution coverage is covered under required Contractor's Pollution Liability Insurance.

3.3 Workers' Compensation

Contractor shall comply with Workers' Compensation coverage as required by the Industrial Insurance laws of the State of Washington, as well as any other similar coverage required for this work by applicable federal laws of other states. Contractor must comply with their domicile State Industrial Insurance laws if it is outside the State of Washington.

3.4 Employers' Liability Insurance

Contractor shall maintain Employers' Liability coverage with limits not less than One Million Dollars (\$1,000,000) each employee, One Million Dollars (\$1,000,000) each accident, and One Million Dollars (\$1,000,000) policy limit.

3.5 Excess or Umbrella Liability Insurance

Contractor shall provide Excess or Umbrella Liability Insurance with limits not less than Three Million Dollars (\$3,000,000) per occurrence and in the aggregate. This coverage shall apply, at a minimum, in excess of primary underlying Commercial General Liability, Employer's Liability, Pollution Liability, Marine General Liability, Protection and Indemnity, and Automobile Liability if required herein.

3.6 Pollution Liability Insurance

Contractor shall maintain Pollution Liability or Environmental Liability Insurance with limits not less than One Million Dollars (\$1,000,000) each occurrence and Two Million Dollars (\$2,000,000) in the aggregate. Coverage shall include investigation and defense costs for bodily injury and property damage, loss of use of damaged or destroyed property, Natural Resource Damage, and Hazardous Substance Removal. Such coverage shall provide both on-site and off-site cleanup costs, cover gradual and sudden pollution, and include in its scope of coverage the City of Tacoma damage claims for loss arising out of Contractor's work.

3.7 Commercial Property Insurance

Contractor shall provide Commercial Property Insurance for loss or damage to any and all equipment owned by City of Tacoma while in the care, custody, or control of Contractor, Subcontractors, or their agents. The coverage shall be provided on an ISO **Special Form Causes of Loss** CP10 30 06 07 or equivalent and shall provide full replacement cost coverage. The deductible shall not exceed Two Thousand Five Hundred Dollars (\$2,500). Contractor shall be responsible for paying the deductible for the applicable coverage.

3.8 Other Insurance

Other insurance may be deemed appropriate to cover risks and exposures related to the scope of work or changes to the scope of work required by City of Tacoma. The costs of such necessary and appropriate Insurance coverage shall be borne by Contractor.

INTENT & AFFIDAVIT INFORMATION FOR ON-CALL CONTRACTS

- A. One Intent to Pay Prevailing Wages (Intents) and a corresponding approved Affidavit of Wages Paid (Affidavits) are to be filed for each 12 month (one year) period of the contract performance for the Contractor and all subcontractors of any tier. Intents for the Contractor and all subcontractors shall be filed prior to any payment for work performed following contract execution. Following the first 12 month period, Affidavits must be received prior to final payment for work performed during the first 12 month period. New Intents shall be filed prior to any payment for work performed during the second 12 month period for the Contractor and all subcontractors. Affidavits from the Contractor and all subcontractors must be received from Washington State's Department of Labor and Industries (L&I).
- B. Immediately following the end of all work completed under this Contract, the Contractor, and each subcontractor of any tier, shall file an approved Affidavit of Wages Paid with the L&I.
- C. The Contractor shall post in a location readily visible to works at the Project site (1) a copy of the Intent approved by the Industrial Statistician at L&I and (2) the address and telephone number of the Industrial Statistician at L&I to whom a complaint or inquiry concerning prevailing wages may be directed.
- D. If a State of Washington prevailing wage rate conflicts with another applicable wage rate (such as Davis-Bacon Ace wage rate) for the same labor classification, the higher of the two shall govern.
- E. Pursuant to RCW 39.12.060, if any dispute arises concerning the appropriate prevailing wage rate for work of a similar nature, and the dispute cannot be adjusted by the parties of interest, including labor and management representatives, the matter shall be referred for arbitration to the Director of the Department of Labor and Industries, and his or her decision shall be final, conclusive and binding on all parties involved in the dispute.
- F. The Contractor shall defend (at the Contractor's sole costs, with legal counsel approved by the City of Tacoma), indemnify and hold the City harmless from all liabilities, obligations, claims, demands, damages, disbursements, lawsuits, losses, fines, penalties, costs and expenses, whether direct, indirect, including but not limited to attorneys' fees and consultants' fees and other costs and expenses, from any violation or alleged violation by the Contractor or any subcontractor of any tier of RCW 39.12 ("Prevailing Wages on Public Works") or Chapter 51 RCW ("Industrial Insurance"), including but not limited to RCW 51.12.050.
