## **SECTION I – SPECIAL PROVISIONS**

#### 1.01 - SCOPE OF BID

#### <u>1.01.1 - PURPOSE</u>

The purpose of these Specifications is to define the scope of supply of materials that meet the minimum requirements as to quality, function, and capacity as outlined in the Special and Technical Provisions that follow.

#### 1.01.1A - AWARD OF CONTRACT

With this solicitation, the City intends to award a single contract and does not anticipate award to multiple Suppliers. Regardless, the City reserves the right to award to one or more Suppliers, or make no award, in the best interest of the City.

#### <u>1.01.2 - DEFINITIONS</u>

For the purposes of this specification, the following definitions shall apply:

RESPONDENT	A potential Supplier offering a submittal to supply equipment in accordance with these Specifications
SPECIFICATION	This document, detailing the scope of supply
SUPPLIER	The Respondent(s) awarded a contract pursuant to these Specifications

#### 1.01.3 - QUALIFICATIONS

To further detail the requirements of Section 1.18.A.6 of the City of Tacoma Standard Terms and Conditions, only submittals which offer products from manufacturers experienced in the supply of materials as detailed within this Specification over a period of *five (5) years* or more will be considered responsive.

#### **1.02 - CONTRACT**

#### 1.02.1 - CONTRACT PERIOD

The contract is intended for a minimum of *three (3) years* from the award date of the contract.



#### 1.02.2 - CONTRACT EXTENSIONS

Two (2) contract extensions of up to one-year per occurrence may be considered upon mutual agreement of both parties to extend the contract under the same terms and conditions of the original contract.

#### 1.02.3 - AWARD DATE OF CONTRACT

The <u>Award Date of Contract</u> is the date that the City of Tacoma Purchasing Division issues the contract.

#### 1.02.4 - TERMINATION OF CONTRACT

The City reserves the right to cancel the Contract at any time upon prior notice to the Supplier (refer to City of Tacoma Standard Terms and Conditions Section 1.27).

#### 1.02.5 - EXPANSION CLAUSE

Any resultant contract from this RFB may be further expanded in writing to include other related services or products normally offered by the Contractor, as long as the price of such additional services or products have a profit margin equal to or less than that in place at the time of original submittal. Such additions and prices will be established in writing. New items not meeting these criteria will not be added to the contract. Contractor profit margins are not to increase as a result of contract additions.

Any new products or services accepted by the City may be added to this contract and/or substituted for discontinued products or services. New products and services shall meet or exceed all Specifications of original award.

#### 1.03 - PRICING AND PURCHASE ORDERS

#### 1.03.1 - PRICES QUOTED

Per City of Tacoma Standard Terms and Conditions Section 1.16, the prices quoted on the Proposal Pricing Sheets shall remain open for acceptance by the City for a minimum of 90 days from the submittal deadline. **The prices quoted on the proposal sheets shall be firm for the first year of the contract.** Subsequently the prices may be adjusted annually per Section 1.03.4.

#### 1.03.2 - FREIGHT ALLOWANCES

The Respondent shall provide prices including delivery F.O.B. Destination, Pre-Paid and Allowed (included in unit price), as noted on the Proposal Pricing Sheets.

#### 1.03.3 - QUANTITIES AND PURCHASE ORDERS

The quantities listed on the "Proposal - Pricing Sheet" are an estimate only using historical data gathered from the previous six (6) years. The City reserves the right to increase or decrease quantities under this contract and pay according to the unit prices quoted in the proposal (refer to City of Tacoma Standard Terms and Conditions Section 1.35). The purchase order will be delivered to the Supplier by email.

#### 1.03.4 - ANNUAL PRICING ADJUSTMENT

The successful Respondent(s) may submit a request to escalate the unit prices of the items bid annually, on the anniversary date of the contract award. Documentation supporting the request shall be included.

Price increases will be adjusted only to the amount of cost increase to Supplier. No adjustment will be made for Supplier's profit margin. The City reserves the right to accept or reject all such price adjustments.



#### 1.03.5 - UNSCHEDULED ADJUSTMENTS

At the City's discretion, the pricing adjustment terms may be waived for extraordinary conditions that could not have been known by either party at the time of bid or other circumstances beyond the control of both parties.

Requests for increases or decreases, other than scheduled, shall be sent to the Engineer/Contract Manager accompanied by documentation supporting the requested change. No other individual or City Department is authorized to approve such modifications. Changes shall be considered effective upon Supplier's receipt of a revised contract document. Concurrence is implied unless Supplier rejects the changes in writing immediately upon receipt of the revised contract document.

#### 1.03.6 - PROMOTIONAL PRICING

City is entitled to any promotional pricing during contract period that is lower than the Vendor's pricing as provided in bid. This promotional pricing shall include, but not be limited to: sale prices, price lowering, and/or lump-sum rebates.

#### 1.04 - RESPONDENT'S PROPOSAL

#### 1.04.1 - ENGLISH LANGUAGE REQUIREMENTS

All drawings, correspondence, catalogs, submittals, nameplates, etc., shall be in the English language as used in the U.S. Dimensions and tolerances shall conform to ANSI Y14.5M and shall be in the U.S. customary units. If units are fabricated utilizing SI units (metric system), both units shall be shown on the drawings, nameplate, etc.

#### 1.05 - ITEMS TO BE INCLUDED WITH SUBMITTAL

#### 1.05.1 - PRODUCT DATA SHEETS

The Respondent shall include with their submittal manufacturer product data sheets (cut sheets) for each material to be supplied. Manufacturer data furnished <u>must be sufficient in detail and clarity</u> to enable making a complete and positive check with compliance of the Technical Provisions of this Specification.

#### 1.05.2 - MANUFACTURER'S QUALITY ASSURANCE POLICY

One (1) copy of the manufacturer's internal "Quality Assurance" policy for the equipment to be supplied shall be included with the submittal. The documentation shall include third party certification of ISO 9000 series qualifications if it has been achieved. The policy documents shall include examples of inspection processes and quality control measures utilized to insure supply of a reliable product.

#### 1.06 - SAFETY AND STANDARDS

The Items supplied shall meet appropriate ANSI, OSHA, WISHA, and all federal, state, and local standards for its intended use. Refer to Section Technical Provisions 2.01.4 for specific industry standards that apply to the Specifications of this bid.

#### 1.07 - MATERIALS, DESIGN, WORKMANSHIP, AND TRADE NAMES

Unless otherwise noted in this Specification, all materials and equipment incorporated into any item covered by the Specifications shall be new and of the most suited of their respective kinds for their intended use. All workmanship shall be in accordance with accepted industry practices.

#### 1.08 - EVALUATION & AWARD

Respondents are to provide unit or lump sum pricing for each line item, which will be summed for a subtotal price. Subtotals will be compared amongst each Respondent, including any offered payment discount terms of 20 days or more.



#### 1.08.1 - AWARD OF CONTRACT

The Contract will be awarded to the lowest and best responsible Respondent(s) delivering a responsive submittal in compliance with these Specifications, provided such submittal is reasonable and it is in the best interests of the City to accept. The City, however, reserves the right to reject any and all bids and to waive any informalities in bids received. The award of this contract will not be based on cost alone, as other factors will be considered in the evaluation criteria

#### 1.08.2 - EVALUATION CRITERIA

In evaluating the proposals, the City will consider any or all of the following:

- Compliance with Specifications
- Proposal prices, listed separately if requested, as well as a lump-sum total
- Minimum order requirements

#### 1.08.2A - OTHER ELEMENTS

The City may also take into consideration other criteria for determining award. Other elements or factors, whether or not specifically provided for in this Specification, which would affect the final cost to and the benefits to be derived by the City, may be considered in determining the award of the contract. The final award decision will be based on the best interests of the City.

#### 1.09 - PACKING AND SHIPPING

The Supplier shall be responsible for industry standard packing that conforms to the requirements of the carrier's tariffs and the ICC regulations.

#### 1.09.1 - **LABELING**

Each pallet and/or box shall be labeled with:

- Quantity
- City of Tacoma Purchase Order Number

#### 1.09.2 - SHIPPING REQUIREMENTS

The City retains the option to have the merchandise delivered to an alternate facility or on-site within a 35-mile radius of the Tacoma Power Warehouse. Notification of any change will be on the purchase order release.

#### 1.11 - INSPECTION & WARRANTY

All goods are subject to final inspection and acceptance by the Engineer and Tacoma Power Warehouse employees.

#### 1.11.1 - FAILURE OF INSPECTION

Material failing to meet the requirements of this contract will be held at Supplier's risk and may be returned to Supplier. If so returned, the cost of transportation, unpacking, inspection, repackaging, reshipping, or other like expenses are the responsibility of the Supplier.

Charges for dismantling and reinstallation of materials furnished pursuant to the Contract will be the responsibility of the Supplier only when a change out or replacement is required because of a suspected or known design defect or large scale failure of manufacturer's quality control system.

#### 1.11.2 - FACTORY INSPECTION

The Engineer/Contract manager shall be permitted to witness the manufacture of items supplied per this contract and to perform a "quality audit" of the facility manufacturing.

#### 1.11.2A - QUALITY ASSURANCE AUDITS

The City or its representative may audit the quality assurance program at any time prior to and during the Contract period or its extensions.

#### 1.11.2B - QUALITY ASSURANCE DOCUMENTATION

The manufacturer shall provide, when requested, access to and copies of quality assurance documents such as material certificates, inspection and test results



obtained in the course of quality assurance, control charts, and other quality documents compiled during the work.

#### 1.11.2C - FACTORY ASSISTANCE DURING INSPECTION

The manufacturer shall have engineering, manufacturing, quality control, and operational factory personnel available who speak technical and conversational English without the need of an interpreter.

#### <u>1.11.3 - WARRANTY</u>

Unless a longer period is specified, the Supplier and/or manufacturer of the supplies, materials and/or equipment furnished pursuant to this Contract agrees to correct any defect or failure of the supplies, materials and/or equipment which occurs within **one year** from the date of commencement of use, however, said warranty period shall not extend beyond **eighteen months** after date of receipt by the City.

When the Supplier is not the manufacturer of the item of equipment, Supplier agrees to be responsible for this warranty and Supplier is not relieved by a manufacturer's warranty.

#### 1.11.3A - WARRANTY PERIOD EXTENSION

The Contract warranty period shall be suspended from the time a significant defect is first documented by the City until the material is repaired or replaced by Supplier and accepted by the City. In addition, in the event less than ninety (90) days remain on the warranty period (after recalculating), the warranty period shall be extended to allow for at least ninety (90) days from the date the work or equipment is repaired or replaced and accepted by the City.

#### 1.11.3B - WARRANTY WORK

All materials requiring warranty work will be returned to the manufacturer at its expense or the manufacturer may replace the defective materials. All replaced materials will be held for pick up (no more than) 30 days after the arrival of replacement materials. Tacoma Power at its discretion will dispose of any materials not picked up within 30 days.

#### 1.11.3B.1 - RETURN TIME FRAME

All warranty repair work on returned material/equipment shall be accomplished within the specified lead-time for delivery listed in the Supplier's bid submittal. Warranty repair time will be calculated from the time the material/equipment defect or failure is reported to the Supplier.

#### 1.12 - INVOICES & PAYMENT

All items called for in these Specifications, including, but not limited to, the necessary drawings and test results, must be supplied to the City before the final invoice can be processed.

#### **1.12.1 - INVOICES**

#### **1.12.2 - PAYMENT**

Upon certification by the Engineer and/or appropriate warehouse personnel that the items have been received in accordance with the Specifications and are in satisfactory condition, a 100 percent payment will be made. Payment methods include:



- A. Credit card. Tacoma's VISA procurement card program is supported by standard bank credit Suppliers and requires merchants abide by the VISA merchant operating rules.
  - 1. Vendors must be PCI-DSS compliant (secure credit card data management).
  - 2. Vendors must be set up by their card processing equipment provider (merchant acquirer) as a minimum of a Level II merchant with the ability to pass along tax, shipping and merchant references information.
- B. Electronic Funds Transfer (EFT) by Automated Clearing House (ACH).
- C. Check or other cash equivalent.
- D. The City may consider cash discounts when evaluating submittals. See 1.20.A.2 of the Standard Terms and Conditions.

#### 1.12.2A - UNSATISFACTORY PERFORMANCE

In the case of unsatisfactory performance, the payment shall be made after the Supplier has made the necessary repairs and/or modifications and satisfactory performance is obtained, or the unit is replaced.

#### 1.13 - EQUITY IN CONTRACTING

The City of Tacoma is committed to encouraging firms certified through the <u>Washington State Office</u> of <u>Minority and Women's Business Enterprise</u> to participate in City contracting opportunities. See the TMC 1.07 Equity in Contracting Policy at the City's Equity in Contracting Program website.

#### 1.14 - STANDARD TERMS AND CONDITIONS

City of Tacoma Standard Terms and Conditions apply.

# **SECTION II – TECHNICAL PROVISIONS**

#### 2.01 - SCOPE

These specifications cover the requirements of faulted circuit indicators (FCI's) and accessories for Tacoma Power. In general, the FCI's are to be hot stick applied with self-adjusting trip rating, timed reset and LED indicator.

#### **2.01.1 – APPLICATION**

Fault locating on underground 15kV distribution voltage cables.

#### <u>2.01.2 – STANDARDS</u>

All FCI's shall meet the most recent editions of the following standards:

#### 2.02 - OPERATING CHARACTERISTICS

The units shall meet the following operating characteristics:

#### 2.02.1 – MOUNTING REQUIREMENTS

The unit shall be able to be installed:

- with one hot stick.
- directly on the cable or loadbreak elbow.

#### 2.02.2 - LOAD TRACKING AND MEMORY

The units will be capable of:

- load tracking at 50A or above.
- peak load memory of a minimum of 72 hours.

#### 2.02.3 - TRIP OPERATION

The unit shall trip in 12 cycles under the following conditions.

If the load current is	The unit will trip at	
50A or below	200A	
above 50A	approximately 4 times the tracked load current	

#### 2.02.4- RESET

• The unit will reset in four (4) hours +/- 10% after the unit has been tripped.

#### 2.03 - EXTERNAL CHARACTERISTICS

#### 2.03.1 - ENCLOSURE REQUIREMENTS

The units shall be enclosed within a high-grade thermoplastic or fiber reinforced polymer housing. All electronics shall be encapsulated within potting material or hermetically sealed.

#### 2.03.2 - INDICATOR REQUIRMENTS

- Flashing bright LED
- 30 flashes per minute
- 30 degree viewing angle

#### 2.03.3 - NAMEPLATE REQUIREMENTS

A permanent nameplate shall be included on the unit with the following information:

- Manufacturer's Name
- Date of Manufacturer
- Model Number
- Time Delay Rating

#### 2.03.4 - CURRENT TRANSFORMER

Closed core stainless steel

#### 2.03.5 - CABLE DIAMETER

Two sizes of units will be required for the smaller and larger diameter cables used in the Tacoma Power distribution system. The cable diameter ranges shall be:

• Item #1 – 0.8 in. to 1.6 in.
