WHEREAS the study further identified the need for more down payment 1 assistance options at higher amounts to help bridge the gap between home 2 prices and a mortgage that is affordable, and 3 WHEREAS the City was awarded additional funds in the amount of 4 \$1,000,000, and 5 6 WHEREAS the City's Community and Economic Development 7 Department recommends an agreement with the Washington State Department 8 of Commerce, in the amount of \$1,000,000 for down payment assistance, and 9 an amendment to the contract with the Tacoma Community Redevelopment 10 Authority for the total amount of \$2,500,000, through November 1, 2050, for 11 12 homebuyer education and first-time homebuyer down payment assistance, and 13 WHEREAS, under the grant process guidelines, the City Council must 14 approve acceptance of grant funding; Now, Therefore, 15 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA: 16 Section 1.
