To The Tacoma City Council,

I urge you to reject the proposed Land Use Regulatory Code Amendments. I write to you as a long-practicing architect (30 years) and former member of the Seattle Design Review Board and participant in the overhaul of the Multifamily section of Seattle's Land Use Code in 2010.

The proposed amendments are neither necessary nor an improvement to the current code. They do not make sense for midscale projects (lots 25-75 feet wide). They do not harmonize with other land use- and architectural requirements and will only frustrate developers and architects as they try to make projects pencil out. They introduce new restrictions that will decrease density and drive up the cost of construction, and thereby reduce the housing supply over time. The net result will be a degradation of the housing situation in Tacoma.

I have shared earlier with the City (both planning staff and the Planning Commission) detailed objections to the amendments and have tried to point out the consequences of the new restrictions, which have not been adequately analyzed and vetted by the City. It is frustrating to see the process move forward without even an acknowledgment that there are problems with the proposal.

As an architect/developer I am inclined to move my work elsewhere as I watch the Land Use Code become more irrational and more politicized over time. They take Tacoma in the wrong direction and therefore I ask you to reject these amendments.

I am extremely opposed to this proposal moving forward.

Most of the public has never heard of this yet, nor have been able to get much information about it.

Written comments for the 4/23/24 Public Hearing are required to be submitted prior to residents being able to see that same day's Study Session or City Council meeting presentation, and the short "Summary" available is extremely vague, mostly saying:

New development proposals larger than a certain size in the designated Mixed-Use Centers would be subject to the UDPR permit process.

... when in actuality, this would be another a group of non-elected business/developers with the authority to approve largest scale developments in some of the most marginalized communities and environmentally critical areas of the city... while exempting projects from individual SEPA reviews plus limiting community members' input!

This is far too extreme and in far too much of a rush (which raises red flags, itself) as well as this being another appointed committee from those within the industry, which creates a serious conflict of interest.

For years now, many on this council, the City Manager's office and PDS have been claiming there's "nothing we can do" about current policy allowing for terrible projects to be approved, but keep hinting that will be corrected... however, instead, we're seeing suggestions like this which are only further "streamlining" the permitting process for the convenience of developers, further weakening the City Council, while skipping more steps and protections while still avoiding the serious omissions previously identified.

From the little I've been able to comprehend of it, this seems to be requesting for new land use permitting. Residents of South Tacoma submitted for a new land use code (over three years ago) which has still been delayed and delayed and diluted while condescendingly told to us that code change is "complicated" and takes time... all the while seeing the City push through faster and faster permitting, and now this brazen proposal.

I'm not sure when this City went so terribly wrong, but the point of a Planning Department is <u>not</u> to find every means possible to approve every project (no matter what the cost to livability and public health), for the sake of the nation's easiest permitting. I am writing to request that this new Urban Design Board package..that includes a new 'land use permit code amendment'.. not be considered for approval for the following reasons:

(1) the 'Designated Mixed use Centers' where this New permit process will be used will include a number of areas within the South Tacoma G roundwater Protection District (STGPD)..including the 'Tacoma Mall Regional Growth Center'. 'South Tacoma Way Neighborhood' and 'Central Tacoma Crossroads Center' and a portion of the 'Downtown Regional Growth Center'. This UDPR Board and permit review proposal is (according to the Planning Commision statements with 'findings of facts' 10/18/23 report) "categorically EXEMPT FROM THE SEPA review process. No environmental review(and, therefore no mitigations) would be required with the REQUIRED use of this UDPR permit review system in these designated development areas of Tacoma. These STGPD-related designated areas that require use of this new permit process would, therefore, not have any required environmental

protections for the Aquifer. This new permit system could adversely affect both the 'quality' and 'quantity' of the water in the Aquifer. Further pollutants could enter the aquifer AND with the impervious surface areas increases (from development projects and the 100+ acres pervious surface loss anticipated with the Bridge Industrial project). Would adversely impact the quantities of water available to recharge the Aquifer

(2) This new permit process (written as an amendment to the TMC) WOULD PLACE LEGAL AUTHORITY for permit review and decisions on large-scale development projects into the hands of a group of business and development-related VOLUNTEERS. The other control over the permit decisions for these 'mixed-use' growth areas'...using this required new permit process..would be solely handled (legally) by the Director of the Planning and Development Services (PDS) Dept. Remember what happened with the Bridge Industrial project permit application..that was approved solely as an Administrative Decision' by the Director of the PDS Dept..legally according to the TMC?

Approving this new land permit system would be akin to providing a 'blank check' to the PDS Dept and construction companies to be able to make decisions legally on very large projects in Tacoma! While this process may (on the surface) seem streamlined and efficient, it offers no environmental protections and no asurances that a livable environment (that includes climate change considerations) for residents would bea future plan.

(3) The only 'Appeal' process option available to be used with the 'Urban Design Board and Permit Review' decisions is the appeals through the Hearing Examiner(HE). Using this HE Appeals process requires a \$1,400 fee be paid. The lowest equity areas of Tacoma..that would be most impacted with the use of this UD Board review process..can least afford to pay that huge fee. This new 'UD Board and Permit Review' process...to be required now in designated 'growth centers' has not considered or factored in ' Equity' considerations...especially in these 'low' and 'very low' equity areas of Tacoma! Obviously havingto pay this \$1,000+ fee would limit any Appeals for decisions using this new permit system.

Please urge another approach be used:

Tomorrow night (Tues 4/23 at 5:15 pm during the City Council meeting) a PUBLIC HEARING is being held on the Planning Dept's

'Urban Design Board and Permit Review' proposal...also to be referred to as the "Urban Design Code". This new Chapter section of the Municipal Codes (Chapter 13.19) would be a group of business/developer volunteers (Urban Design Board) the LEGAL AUTHORITY to make decisions to approve the largest scale (greater than 100,000 sq ft) of building projects to be located in designated 'mixed use' areas of Tacoma...WITHOUT ANY REQUIRED ENVIRONMENTAL REVIEWS. In fact, the Planning Commission, in their 10/2023 'finding of facts' report, reported that the use of this new 'Urban Design Board and Permit Review' system would be "categorically EXEMPT FROM SEPA review process". Four of these designated 'mixed-use' areas are on land sites in the 'South Tacoma Groundwater Protection District' (STGPD) area..above a major Aquifer that is used as a drinking water source during drought conditions during summers in Tacoma.

Major Concerns and Reasons to NOT approve this new permit system:

1. South Tacoma Groundwater Protection District (STGPD) updates are years overdue..and the STGPD Moratorium has been extended already..with a still unknown completion timeline (OR, 'timeline information known..but, not shared with

the residents)

2. With No environmental protections with projects planned in these 'mixed use areas', the STGPD (aquifer) is not adequately protected with the water QUALITY (potential for unknown/unstudied environmental impacts/Pollutants added to the Aquifer) and the WATER AMOUNTS needed for re-charge of the Aquifer system. With more concentrated housing and business development (in at least four of these mixed-use areas in Tacoma) an increase in impervious surfaces would be anticipated.

3. No assurances or plans are in place to increase the 'tree canopy' of these "tree deficient" areas of South Tacoma and other Tacoma neighborhoods. Instead 'Departures' (variances) are made available to business developers to exclude tree and vegetation in the planning of projects in these designated mixed-use areas.

4. The 'goal' and 'intent' with the creation of this new 'land use permit' is to provide a "streamlined' permit process that businesses and developers can use that assures consistent and quick approvals of permits...without the inclusion of environmental issues into permit decisions and minimizes/controls the residents input into thesevaporoval decisions. So..this new permit review/approval system use could completely meet the shorter term financial goals of builders and land developers.

Mayor and members of the City Council. Over the next several months I will be presenting several areas of concern that the council and the public need to be aware of. The data and information that I have collected are through public disclosure request as well as information that I have received from various emails between me and city staff. The following are items of interest that I will be covering:

- Harrison Shooting Range 101 McMurray Rd. NE Tacoma- Highly contaminated soil with lead and other heavy metals in both City owned parcels. Concern is contamination of the soil, ground water and storm water leaving the site and entering the Hylebos Waterway contaminating the waterway and the Puget Sound. This has been going on for over 50 years needs to stop and the range transition to use only lead free ammunition. All contamination from the 2 city owned parcels as well as the contamination of the Hylebos Waterway need to be mitigated for the safety of citizens, environment and the waters of the Puget Sound.
- 2.
